**SUBJECT:**

Approval to Accept an Update on the Non-Profit Support Grant Program and Authorization to Distribute Grant Funding

**STAFF RECOMMENDATION:**

1. Accept an update on the Non-Profit Support Grant Program.
2. Authorize the Chief Executive Office to distribute grant funds as recommended by the Non-Profit Support Grant Program Selection Committee.

**DISCUSSION:**

On August 25, 2020, the Board of Supervisors approved the Non-Profit Support Grant Program to provide assistance for non-profit organizations that provide services to youth, or community-centered arts and culture programs. This program was established to award grants, through a competitive process, to non-profit organizations based on the level of impact of the COVID-19 pandemic to the respective non-profit organization.

Non-profit organizations were required to meet certain requirements in order to be eligible for this grant program. Eligible organizations were able to complete one application to be considered for a grant from both funding categories but unable to request more than \$300,000 from each fund.

An agreement was executed with the Stanislaus Community Foundation to provide administrative support for this program. The Stanislaus Community Foundation has been in existence since 2002 and is focused on improving the lives of the residents and the vibrancy of the unique and diverse communities throughout Stanislaus County. The Non-Profit Support Grant Program was modeled after the Stanislaus Community Foundation Resilient Stanislaus Fund that provided support for non-profit organizations in Stanislaus County that were particularly affected by the outbreak of COVID-19 and provided services around jobs and economy, social and emotional needs, arts, culture and youth.

The grant application period for the Non-Profit Support Grant Program opened on September 9, 2020 and closed at 5:00 P.M. on September 25, 2020. At the close of the application period, and after the initial screening by Stanislaus Community Foundation staff, 61 applications requesting over \$3.2 million were moved to the evaluation phase of the process. A greater number of applications received were from the youth services

category (\$1.9 million) versus the community-centered arts and culture category (\$1.3 million).

A volunteer Selection Committee composed of a cross-section of community representatives scored applications based on the evaluation criteria and rubric approved by the Board of Supervisors on September 15, 2020. The evaluation criteria and rubric focused on the following areas:

- Organizational Focus & Relevancy (30%).
  - How strong does the organization's core work focus on arts, culture and/or youth?
  - Is this organization or program providing an in-demand service to the community based on the number of people served and the frequency of programs offered?
  - Who are the key populations served by the organization?
- COVID-19 & Financial Impact (40%).
  - How clearly has the organization demonstrated need?
  - Will this investment help the organization stabilize and/or adapt in response to the COVID-19 crisis?
  - How much has the COVID-19 crisis impacted the organization's operations?
  - How has COVID-19 impacted the organization's revenues and expenditures?
- Budget Considerations (30%).
  - Does the organization demonstrate a reduction in revenues between 2019 and 2020 financials?
  - Does the organization demonstrate an increase in expenditures between 2019 and 2020 financials?
  - Does the organization have access to other resources to address the need?

The evaluation process was administered by Stanislaus Community Foundation but vetted by this independent Selection Committee of diverse community members who signed disclosures indicating no conflict of interest with the grantee pool. The vetting process included an online full application review for each application by three evaluators; the individual scores were then averaged and taken into consideration along percentiles that were discussed at length during the Selection Committee program award meeting.

The Selection Committee recommended funding for a total of 50 organizations. Of the \$2 million allocated for this program \$1,135,250 was recommended in the youth services category and \$864,750 in the community-centered arts and culture category which was reflective of the applications received.

The following table identifies the non-profit organizations that were recommended for

As previously mentioned, the Non-Profit Support Grant Program produced a good response from the non-profit sector and highlighted a critical local need resulting from COVID-19 pandemic conditions. All organizations have provided services to residents in the Stanislaus County and are worthy of support. Due to limited funding, not all organizations were recommended funding at the requested amount.

Of the applications received, 11 were not eligible for funding at any level. There are multiple factors that are taken into consideration when scoring grant applications, especially in a competitive grant cycle with limited funds. Along with the criteria established for awards, there are also multiple reasons an organization may not receive any funding. This may include the inability of the applicant to provide necessary financial reports or other substantiation information; not adequately addressing financial need and/or impact of COVID-19 on their operations; or not in great need for limited CARES Act grant funds given other resources available to the organization.

Like other programs developed using the CARES Act CRF funds, the Board of Supervisors can allocate additional funding if it deems appropriate upon considering other organizational and community priorities. If the Board is interested in allocating additional funding to the Non-Profit Support Grant Program, staff recommends it designate a specific amount and direct staff to work with the Stanislaus Community Foundation and the Selection Committee to distribute per the existing program guidelines. County staff can then bring this item back to the Board for consideration and approval at a subsequent regular meeting.

Staff recommends award of the grants to the non-profit organizations as provided by the Selection Committee at the Board approved \$2 million level. All grant applicants have been notified of the results of the competitive process and received letters of award or declination. Upon Board approval of this item, County staff will work with each non-profit organization that is awarded a grant to ensure that required documentation is completed for accounting and tracking purposes in order to process funding in a timely manner.

**POLICY ISSUE:**

Board of Supervisors' approval is required to set the local policy for the use of CARES Act CRF funds. The United States Treasury language provides that expenditures of the CRF funds must be used for actions taken to respond to the public health emergency, including economic support to those suffering from employment or business interruptions due to the COVID-19 emergency response. Financial assistance to local non-profit organizations impacted by the pandemic is consistent with this federal guidance.
