Supervisor Simon requested an update from the Sheriff's department on the use of the narcotics sniffer machine. The CEO noted that he would have the Sheriff's department provide a status update to the Board regarding this matter.

Supervisor Mayfield spoke regarding the reappointment process for the Turlock Rural Fire Protection District and other Boards and Commissions. He asked that all the Board of Supervisor members be consistent in applying any applicable term limitations. County Counsel noted that he would look into this issue and report back to the Board. Supervisor Mayfield also noted that he participated in a Water Board conference call yesterday, and they discussed a proposed 60 billion-dollar bond for water related projects. The CEO noted that he would incorporate findings for flood control projects into the 2006 State Legislative Platform. He expressed his appreciation to the Clerk of the Board and to Bob Carpenter, Facilities Manager, for the improvements to the Board Chambers sound system. He gave an update on AB 959 Frommer, which would qualify Stanislaus County to receive reimbursement under the Certified Public Expenditures Program and noted that it will be heard in January before two committees. The CEO reported that staff has been working with the Courts regarding the distribution of civil assessments and that they have reached an accord and settled all the issues. The net benefit to the County will be a reduction of approximately \$600,000 per year in supporting the trial courts. He thanked Judge Silvera, Auditor-Controller Larry Haugh, CEO staff, Mike Tozzi and Don Lundy for their work on this project.
