- \*B10 Accepted the Stanislaus County Treasury Pool’s January 2006 Monthly Investment Report as prepared by the Stanislaus County Treasurer-Tax Collector’s Office and reviewed for conformity with the Treasury Pool Investment Policy by the Treasurer-Tax Collector and distributed to the Treasury Pool Oversight Committee; and, authorized the Chairman to sign on behalf of the Board that the report has been reviewed and accepted – T/TC 2006-161
- \*C1 Approved the installation of stop sign traffic control, under the authorization granted to local authorities in Vehicle Code §21355, at River Road at Avon Street; required motorists on all approaches to stop prior to entering the intersection; and, the stop signs shall be located at or near all entrances to said intersection – PW 2006-162
- \*C2 Finds that all street improvements required for Tentative Parcel Map #2004-12 by the Subdivision Improvement Agreement, executed by Daniel S. Donovan and the Stanislaus County Board of Supervisors on 3/15/05, have been constructed to the satisfaction of Stanislaus County; finds that said agreement was recorded on 12/13/05, as Document No. 2005-02264480-00, and filed with the Stanislaus County Clerk Recorder’s Office; accepted all street improvements including the drainage system along the project’s frontages of Washington and Nunes Roads for maintenance by Stanislaus County; pursuant to §66499.7(a) of the Subdivision Map Act, authorized the release of Performance Bond No. 69858070, issued by Western Surety Company in the amount of \$90,000.00 for faithful performance of the Subdivision Improvement Agreement; and, pursuant to §66499.7(b) of the Subdivision Map Act, upon receipt of a Mechanic’s Lien Guarantee, authorized the release of the Labor and Materials Bond (payment bond) No. 69858070, issued by Western Surety Company in the amount of \$90,000.00 for payment of labor and materials, the Mechanic’s Lien Guarantee must be dated a minimum of 61 days after the filing of the appropriate notice of completion, be in the amount of \$90,000.00, be prepared by a title company, be to the benefit of Stanislaus County, and state that there are no liens of record – PW 2006-163

Supervisor DeMartini spoke regarding the number of calls he receives concerning the sewer hook-ups for the Shackelford area. He noted that the project is done, but that they are having difficulty getting the pipes inspected by the City of Modesto so that the residents can be connected. The CEO noted that he would follow-up on this issue and give an update to the Board.

The CEO reported that the Stanislaus County contingent, including representatives from the cities, the County, StanCOG and the Alliance, will be traveling to Washington D.C. next week to work on specific federal legislation that faces our community.
