Tuolumne Road, in Denair; finds the project to be "de minimis" for the purposes of collection of Fish and Game Fees pursuant to California Code of Regulations §753.5, by adopting the findings of fact contained in the attached Certificate of Fee Exemption, those findings being based on the analyses presented in the Initial Study, and ordered the filing of the Certificate of Fee Exemption with the Stanislaus County Clerk-Recorder's Office; adopted the Mitigated Negative Declaration pursuant to CEQA Guidelines §15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Mitigated Negative Declaration reflects Stanislaus County's independent judgment and analysis; ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder's Office pursuant to Public Resources Code §21152 and CEQA Guidelines §15075; adopted the Mitigation Monitoring Plan pursuant to CEQA Guidelines §15074(d); finds that the proposed map is consistent with applicable general and specific plans as specified in §65451; finds that the design or improvement of the proposed subdivision is consistent with applicable general and specific plans; finds that the site is physically suitable for the type of development; finds that the site is physically suitable for the proposed density of development; finds that the designs of the subdivision or the proposed improvements are not likely to cause substantial environmental damage or substantially and avoidably injure fish or wildlife or their habitat; finds that the design of the subdivision or type of improvements is not likely to cause serious public health problems; finds that the design of the subdivision or the type of improvements will not conflict with easements, acquired by the public at large, for access through or use of, property within the proposed subdivision; in this connection, the governing body may approve a map if it finds that alternate easements, for access or for use, will be provided, and that these will be substantially equivalent to ones previously acquired by the public; finds that the project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements; **amended** the Condition of Approval No. 37 to eliminate the river cobbles from the landscape to be replaced by appropriate landscape as approved by the County Planning Department; and, approved Vesting Tentative Subdivision Map Application #2006-01 - Palm Estates, subject to the attached Conditions of Approval/Mitigation Measures as amended – Planning 2006-727

Amended the **9:25am** Public Hearing to Consider the Adoption of the Final Budget for Fiscal Year 2006-2007 to take **two votes as follows**:

First Vote: Mayfield/O'Brien unan. Accepted and approved the recommended Final Budget for FY 2006/07 from the CEO except for the Community Support Budget located on pages 112 and 113 of the FY 2006/07 Final Budget Addendum; conducted the scheduled public hearing to receive public comment on the proposed spending plan; authorized the CEO and the Auditor-Controller to make the necessary technical adjustments to implement the approved Final Budget; directed the CEO and the Auditor-Controller to prepare the Final Budget document in accordance with State law and submit it to the State Controller prior to 12/1/06; amended the Salary and Position Allocation Resolution to reflect the recommended changes in the Final Budget, which provides for position and classification changes (as outlined in the Staffing Impacts section of this report and detailed in Attachment "B") to be effective with the start of the first pay period effective 9/16/06; approved contracts and/or agreements listed on Attachment "C" in cumulative amounts of \$100,000 or greater since 7/1/03; and, approved the reallocation of \$750,000 of FY 2006/07 realignment funds from the CSA welfare sub-account to the BHRS mental health sub-account

Supervisor DeMartini reported that tonight at 6:30 p.m. the first public meeting is being held at Harvest Hall to receive comments regarding the revised Agricultural Element. Another meeting regarding the Agricultural Element will be held on 9/18/06 at Bonita School in Crows Landing.

The CEO announced the upcoming retirement of George Stillman, Public Works Director. He noted that a town hall meeting will be held at Harvest Hall on 9/14/06 at 6 p.m. to help California farmers and ranchers recover from the 2006 Summer Heat Wave. He reported that the Federal Department of Homeland Security has designated September 2006 as National Preparedness Month, and the Governor has proclaimed 9/14/06 as California's Day of Preparedness.

Chairman Simon commented on what a professional George Stillman, Public Works Director, is and that it will be a real loss to the County when he retires.
