- \*D1 Rescinded all or a portion of Williamson Act Contract #1976-2317 (Valley Home Road, in Valley Home) and approved a new contract pursuant to Minor Lot Line Adjustment 2008-15, Alan Patrick, and authorized the Planning Director to execute a new contract; finds the new contract or contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds there is no net decrease in the amount of the

acreage restricted. In cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; finds at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; finds after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in §51222; finds the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; finds the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; and, finds the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan – Planning

\*D2 Rescinded all or a portion of Williamson Act Contract #1997-4351 (Jackson and Beckwith Roads, West of Modesto) and approved a new contract pursuant to Minor Lot Line Adjustment 2008-18, Bowman, and authorized the Planning Director to execute a new contract; finds the new contract or contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds there is no net decrease in the amount of the acreage restricted. O'Brien/DeMartini (4-1)(Mayfield opposed) 6:40 pm Conducted a required public hearing to consider Planning Commission's Recommendation for Approval of General Plan Amendment Application #2007-03 and Rezone Application #2007-03, The Fruit Yard, a request to amend the General Plan designation from Agriculture to Planned Development and to rezone the property from A-2-40 (General Agriculture) to PD (Planned Development) on a 45+/- acre site; this would authorize a Development Plan for the Fruit Yard which would include a 9,000 square foot banquet facility, relocation of the existing fueling facilities, construction of a 3,000 square foot retail shell building, a 322 space RV/boat storage, a 66 space travel trailer park, a new facility for fruit packing, and a 2.00 acre site for retail tractor sales; outdoor events and entertainment are proposed to be held on the park site; the project is located at 7948 Yosemite Boulevard/Highway 132 east of the community of Empire and west of the City of Waterford (APN: 009-027-004); adopted the Mitigated Negative Declaration pursuant to California Code of Regulations §15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Mitigated Negative Declaration reflects Stanislaus County's independent judgment and analysis; finds that the substitute language for Mitigation Measure 3 identified as Development Standard No. 71 is equivalent or more effective in mitigating or avoiding potential significant effects and that it in itself will not

cause any potentially significant effect on the environment; adopted the Mitigation Monitoring Plan, with the substitute language for Mitigation Measure No. 3, pursuant to CEQA Guidelines §15074(d); ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder's Office pursuant to Public Resources Code §21152 and CEOA Guidelines §15075; finds that: (A) The General Plan amendment will maintain a logical land use pattern without detriment to existing and planned land uses, (B) The County and other affected governmental agencies will be able to maintain levels of service consistent with the ability of the governmental agencies to provide a reasonable level of service, (C) The amendment is consistent with the General Plan goals and policies, (D) Overall, the proposal is consistent with the goals and policies of the General Plan, (E) There is evidence on the record to show a demonstrated need for the proposed project based on population projections, past growth rates, and other pertinent data, (F) No feasible alternative site exists in areas already designated or planned for the proposed uses, (G) Approval of the proposal will not constitute part of, or encourage piecemeal conversion of a larger agricultural area to non-agricultural uses, and will not be growthinducing (as used in the California Environmental Quality Act), (H) The proposed project is designed to minimize conflict and will not interfere with agricultural operations on surrounding agricultural lands or adversely affect agricultural water supplies, (I) Adequate and necessary public services and facilities are available or will be made available as a result of the development, (J) The design of the proposed project has incorporated all reasonable measures, as determined during the CEQA review process, to mitigate impacts to fish and wildlife resources, air quality, water quality and quantity, or other natural resources, (K) The proposed Planned Development zoning is consistent with the proposed Planned Development General Plan designation, (L) The project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements, and, (M) Development Standard No. 71 is more effective than the noise mitigation measure circulated with the initial study and mitigation monitoring plan; finds that the proposed Planned Development zoning is consistent with the Planned Development General Plan designation; and, approved General Plan Amendment #2007-03, and Rezone Application #2007-03, including Phases 1, 2, and 3, subject to the modifications to the Development Standards and Development Schedule as recommended by the Planning Commission; amended Development Standard No. 55 to read as follows: "Concurrent with the development of either the RV/Boat Storage or the RV Park parcels, a six-foot high masonry wall, or an MID approved equal, is required along the south line of applicant's property adjacent to MID Lateral 1. This fence shall extend from Geer Road to a point 10 feet west of the proposed "E" Drive right-of-way. If "F" Way is constructed from "E" Street to Triangle Ranch Road or the Agricultural parcel is developed, then the wall must be extended the full length of that development."; amended the Development Standards to add Development Standard No. 69 to read as follows: "No individual "RV Park" space shall be occupied by the same individual, trailer, recreational vehicle, or movable sleeping quarter of any kind for a period exceeding (14) fourteen consecutive days within a one month period. This applies to owner/operator of the RV/camper/trailer, all occupants, and the RV/camper/trailer itself."; and, introduced and waived the reading and adopted Ordinance C.S. 1033 for the approved Rezone Application #2007-03 – Planning ORD-55-H-8 2008-600 2008-601

Supervisor Monteith attended a National Night Out Celebration at Oregon Park on 08/05/08 which was hosted by the Airport Neighborhood United. He was pleased to see the participation of the neighborhood, as well as a mounted Sheriff's Deputy in attendance. He noted that Deputy Sheriff Tom Moebs was praised for not just serving the community but for being part of the community. He thanked Deputy Tom Moebs for the good job that he is doing.

Supervisor DeMartini reported that the West Side Health Care Task Force has been meeting for over a year and that they continue to make steady progress on trying to bring medical services to the West Side community. He noted that the task force is a collaborative effort between Stanislaus and Merced Counties, cities of Newman, Patterson and Gustine, and all the healthcare providers in the District. He reported that last week, he along with staff from the CEO's office and County Counsel had a meeting with Emmanuel Hospital and that they offered their assistance. This Friday they will have a meeting with DMC to see if they can get their support as well.

The CEO announced that there will be a historic groundbreaking of the SR 219/Kiernan Project on 08/29/08. He reported that the State Assembly did vote on the budget over the weekend, and that it is expected the that the Senate will take up the vote tomorrow. He spoke regarding the alternative proposal "Plan B", which would take funds from Prop 1A, Prop 10, Prop 42, Prop 63 in order to balance the State Budget.
