O'Brien/Chiesa unan. **9:15 am** Based upon the staff report, presentations by staff, including PowerPoint presentations, all comments and testimony received during the public hearing, and all materials that were supplied to the Board and were taken into consideration in making the decision, the Board denied the appeal and upheld the Planning Commission's decision of denial of Vesting Tentative Subdivision Map Application #2006-06 and Exception Application #2008-02, Knights Ferry Overlook; the Board finds and determines the following: (a) pursuant to Stanislaus County Code §20.12.140 that the project site is not

physically suitable for the proposed development in that the project would create split zoning, and that the project would result in septic systems that are close to an existing OID canal and an existing pond, which would result in water quality problems; and, (b) finds pursuant to Stanislaus County Code \$20.64.030 that the \$100,000 expense of extending OID water to the site is not a special circumstance or condition that warrants granting an exception – Planning

Supervisor Grover gave an update to the Board regarding the Stanislaus County delegation's trip to Washington D.C. last week and noted that he will distribute a booklet to each Supervisor summarizing the delegation's priorities that were presented to our federal representatives. He commented that the Modesto Bee's article last week did not fully explain the County's request concerning the educational DVD that could be distributed to school children in Stanislaus County as part of gang suppression education.

Supervisor O'Brien reported that he also participated in the delegation to Washington D.C. last week. He spoke regarding the importance of gang suppression education in our community and expressed the need for finding an out-of-the-box approach to prevent gang violence. He noted that the delegation addressed four key projects in addition to the Physician Residency Program issue. Overall, the trip went very well.

Chairman DeMartini reported that the Westley Triangle Business Group will have their second meeting on 3/30/2009, at 6:00 p.m., at the Westley Hotel. This group is developing a plan to make improvements in the Westley area and to attract more businesses.

Supervisor Grover and Chairman DeMartini spoke regarding the lack of federal grants for high tech crime taskforce equipment.

The CEO reported that the delegation to Washington D.C. focused on the following four project areas: gang suppression, public safety interoperability, Tuolumne River Regional Park, and the Orestimba Creek Flood Control Project. He also spoke regarding the federal economic stimulus package and the potential funding for public safety.
