Chairwoman Olsen announced that this meeting will be held in accordance with the Governor's Stay at Home Executive Order N-33-20 and will not include in person public attendance. She reviewed the options for the members of the public to observe the meeting and provide comments to the Board via email or telephone as listed on the first page of the agenda.

Withrow/Chiesa (4-1)(DeMartini opposed) **6.2** Considered a resolution exercising the County's police power to impose substantive limitations on residential and commercial evictions, through 05/31/2020, in response to the 2019 Novel Coronavirus emergency; **amended** the proposed resolution to add Paragraphs 3c and 3d to read as follows: "Residential and commercial evictions commenced before the Governor's Proclamation are similarly suspended to conform to the spirit of the Governor's subsequent "shelter in place order" of 03/19/2020 (Executive Order N-33-20)" and "For purposes of this paragraph commercial property means property occupied by a business consisting of fifty employees or less as of 03/04/2020."; and, the Board adopted the resolution as amended – CEO 2020-0147

Corr 1 Referred to DER, a copy of the 2019 Annual Report on Toxic Emissions from Valley Facilities from the San Joaquin Valley Air Pollution Control District.

Corr 2 Acknowledged receipt of claims and referred to the CEO-Risk Management Division the following claims: Vanessa Silva; and, Anthony Perez, Esq. on behalf of Tamara Riddle-Borges.

The CEO reported that the due date for local property taxes has not been extended. However, the Treasurer-Tax Collector has a process for anyone who is impacted by COVID-19 to petition for the waiver of late payment penalties for property taxes. He reported that the federal government has approved a \$2 trillion relief bill, and the County hopes that it will support our local efforts underway.

Chairwoman Olsen thanked the Clerk of the Board for making arrangements for the board meeting to take place while practicing social distancing and accommodating public comments remotely. She reminded the public that there is information regarding COVID-19 available online at <u>www.stanemergency.com</u> or the StanEmergency Facebook page. There will be a live Q&A session on the StanEmergency Facebook site on 04/01/2020 at 5:30 p.m. with Dr. Vaishampayan, our local Public Health Director. In addition, the County is working on a small business relief package for businesses located throughout Stanislaus County, and she thanked Assistant CEO Keith Boggs for his work on this. Chairwoman Olsen noted the updated COVID-19 numbers: 35 positive cases, 0 deaths, and; 1,100 negative tests and beginning today the County will start breaking out those demographics a little more into cities, etc.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
