*Supervisor Berryhill attended via teleconference pursuant to Governor Newsom's Executive Order N-25-20.

Invocation was given by the Reverend Michael Douglass with Advancing Vibrant Communities.

Chairwoman Olsen announced that this meeting will be held in accordance with the Governor's Stay at Home Executive Order N-33-20 and will not include in person public attendance. She reviewed the options for the members of the public to observe the meeting and provide comments to the Board via email or telephone as listed on the first page of the agenda.

CEO Hayes provided an update on the 2019 Novel Coronavirus (COVID-19) Emergency and noted the updated numbers: 81 positive cases, 0 deaths, and; over 1,600 negative tests. He cautioned that everyone in Stanislaus County should assume that COVID-19 is present in their community. He noted that the County has a team that is tracking the high volume of actions and activity at the State and Federal level on a daily basis. This week's topic will be the modeling of the disease spread. The CEO reminded the public that every Wednesday at 5:30 p.m. there is a Q&A Facebook Live event on the StanEmergency Facebook page and information regarding COVID-19 is available online at <u>www.stanemergency.com</u>

Jacque Wison voiced concerns regarding the Judicial Council's emergency order setting bail at zero for lower-level offenses.

Wendy Byrd, with the NAACP, expressed her thanks for the community collaboration and transparency with temporary measures that were released yesterday and wanted to make sure the community is involved in helping the inmates that are getting released due to the emergency order.

6.1.B.2 Approved the tentative agreement reached between In-Home Supportive Services (IHSS) Public Authority (PA) of Stanislaus County and the United Domestic Workers of America (UDWA), representing the Stanislaus County IHSS Providers, for the period of 04/07/2020 through 06/30/2022; authorized CSA to submit a rate change request to the CDSS to implement the salary and benefit provisions agreed to per the MOU, attached to the agenda item; authorized the Chairwoman of the PA and all parties to sign the agreement; authorized the CEO, or his designee(s), to negotiate and execute an agreement with the UDWA for the Provider Supplies Program at a total cost not to exceed \$30,000, or \$10,000 per fiscal year, funded by IHSS Provider Premium Reserve Funds, should the Provider Premium Reserve Funds be depleted the parties agree this program will end; authorized the CEO, or his designee(s), to negotiate and execute a sole-source agreement with the California Independent Provider Training Center (CAIPTC) for training of IHSS Providers in Stanislaus County at a cost of up to \$176,000, funded by IHSS Provider Premium Reserve Funds, should the Provider Premium Reserve Funds be depleted the parties agree this program will end; and, authorized the CEO, or his designee(s), to negotiate and execute a sole-source agreement with the Union for training of providers in Stanislaus County for a total cost not to exceed \$120,000, or \$40,000 per fiscal year, funded by IHSS Provider Premium Reserve Funds, should the Provider Premium Reserve Funds be depleted the parties agree this program will end - CSA 2020-0156

Chiesa/Withrow unan. 7.1 The Board established a Small Business Relief Program to provide a micro grant program to qualified small businesses, and directed staff to implement the program at the soonest practicable date; authorized the use of up to \$750,0000 in Community Development Funds for the program; authorized the redirection of up to \$250,000 in unused Economic Development Bank Emergency Water Well Assistance Program funding to support the program; appointed the Director of Workforce Development, or designee, as the program administrator; authorized the Director of Workforce Development, or designee, in consultation with the Chief Executive Office, to review and approve grant applications submitted under this program; authorized the GSA Director to negotiate and execute a MOU between Stanislaus County Workforce Development and Valley First Credit Union as a third-party funding distributor; authorized the transfer of \$1,000,000 to the Small Business Relief Program from the Economic Development Bank, and Community Development Fund; the purpose of this funding is to provide a relief program for small businesses in Stanislaus County; directed the Auditor-Controller to make the budget adjustments as reflected in the budget journal, attached to the agenda item; and, amended the item to direct staff to open the Small Business Relief Program application process on Monday, 4/13/2020 at 8:00 a.m. through Tuesday, 4/21/2020 at 5:00 p.m., and challenged the community to match the County's \$1 million for this relief program - CEO 2020-0157

CEO Hayes noted that he received a message recognizing the County's efforts in preparation of alternative care sites is paying off.

Supervisor Withrow reminded the public that, although the tax deadline has been extended to 07/15/2020, he encouraged everyone to complete their taxes before the extended tax deadline.

Supervisor Chiesa thanked Stanislaus County employees for all the work they have been doing; the Small Business Relief Program; 2-1-1 Call Center; Emergency Operation Center; and, the long hours they have been working.

Supervisor Berryhill echoed Supervisors Chiesa's comments.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
