Convened at 5:30 p.m. for Special Session

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

- **1.1** Conference with Director of Emergency Services Threat to Public Services: Pursuant to Government Code section 54957(a), the Board will confer with the Director of Emergency Services and County Counsel regarding matters posing a threat to essential public services and the public's right of access to public services or facilities. No reportable action was taken in closed session.
- 1.2 Conference with Legal Counsel Existing Litigation: Pursuant to Government Code Section 54956.9 (d)(1). Three cases: California Sportfishing Protection Alliance v. All Persons Interested in the Matter of the Validity of the Eastern San Joaquin Groundwater Sub-Basin Groundwater Sustainability Plan, et al., County Superior Court Case No. CV-20-001720; California Sportfishing Protection Alliance v. all Persons Interested in The Matter of the Validity of the Northern and Central Delta-Mendota Regions Groundwater Sustainability Plan, et al., Stanislaus Superior Court Case No. CV-20-001748; and BNSF Railway Company v. Alameda County, et al., United States District Court, Northern District of California, Case No. 4:19-CV-07230-HSG. No reportable action was taken in closed session.

Reconvened at 6:03 p.m. for Regular Session

Chairwoman Olsen announced that this meeting will be held in accordance with the Governor's Stay at Home Executive Order N-33-20 and will not include in person public attendance. She reviewed the options for the members of the public to observe the meeting and provide comments to the Board via email or telephone as listed on the first page of the agenda.

Invocation was given by Rabbi Shalom Bochner with Congregation Beth Shalom.

CEO Hayes provided an update on the 2019 Novel Coronavirus (COVID-19) Emergency and noted the updated numbers: 236 positive cases, about 3,400 negative tests, 133 recovered, and sadly 4 deaths. He thanked Public Health Officer Dr. Vaishampayan for her vision and guidance on how to manage this crisis. The CEO reviewed the different social distancing models and the Coronavirus Aid, Relief, and Economic Security (CARES) Act. He also acknowledged the impacts the Judicial Council's emergency order setting bail at zero for lower-level offenses is having on the community.

Wayne Warren asked the Board to consider opening reservoirs for fishing as an allowable activity.

Miguel Donoso inquired how the County is getting the COVID-19 message to the Community System of Care.

Rebecca Harrington expressed concerns regarding the community not taking the COVID-19 crisis seriously and the need for more public service announcements in Spanish.

Natalie McDonald Ledoux spoke regarding the need for County services.

Danny Betyo spoke in support of essential businesses being open and concerns regarding Paycheck Protection Program small business loans.

- 6.D.2 Rescinded Williamson Act Contract No. 78-3085, located at 13018 Bradbury Road, between Crows Landing Road and S Morgan Road, in the Turlock area, APN: 057-002-004; finds pursuant to Government Code Section 51257, determined that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract, or contracts, would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contract, or contracts, but for not less than ten years, except as authorized under the County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract, or contracts, remains under the new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved a new contract, pursuant to Lot Line Adjustment Application No. PLN2019-0076, Bylsma Family Trust; and, authorized the Director of Planning and Community Development to execute a new contract – Planning 2020-0170
- 6.D.3 Set a public hearing for 04/28/2020, at the 9:00 a.m. meeting, to consider the Planning Commission's recommendation of General Plan Amendment and Rezone Application No. PLN2019-0045, Beeler Development, a request to amend the General Plan, Community Plan, and zoning designations of a 1.08± acre parcel from Low Density Residential and A-2-10 (General Agriculture) to Planned Development to allow for construction of a 19,652 square-foot warehouse building to allow for low-people intensive light industrial, office, and commercial uses, located at 4731 Kiernan Court, north of the Highway 99 and Kiernan Avenue Interchange, in the Community of Salida; and, authorized the Clerk to publish a notice of public hearing as required by law Planning ORD-56-U-2 2020-0171
- 6.D.5 Set a public hearing for 05/12/2020, at the 9:00 a.m. meeting, to consider the Planning Commission's recommendation of Rezone Application No. PLN2019-0093, Tenaya Banquet Hall, a request to amend the zoning designation of a 2.91-acre parcel from Industrial (M) to Planned Development (P-D) to establish a catering and event venue, with two separate event spaces, in an existing 34,720 square-foot commercial building, located at 2206 Tenaya Drive, on the southeast corner of Mitchell Road and Tenaya Drive, in the Modesto area; and, authorized the Clerk to publish a notice of public hearing as required by law Planning

Withrow/Chiesa unan. **8.4** Ratified the Emergency Occupancy Agreement with Dalijeet Singh Mann, Harinder Singh, DJ Management LLC, and American Traders, Inc., for emergency non-congregate sheltering at the Modesto Hotel, 1720 Sisk Road, Modesto, in support of the State of California's Project Roomkey Safe Isolation Projects for homeless individuals; authorized the Director of CSA or her designee, to negotiate and enter into any agreements, in an amount up to \$2.7 million, to secure sites and services in support of emergency non-congregate shelter options in support of the Stanislaus County Public Health Officer's letter, dated 04/02/2020, urging emergency non-congregate shelter be identified to reduce the transmission of COVID-19; and, authorized the Auditor-Controller to make the necessary budget adjustments, increasing appropriations in the CSA's Housing and Homeless Services budget by \$2.7 million, as detailed in the budget journal attached to the agenda item – CSA 2020-0177
