*Supervisor Berryhill attended via teleconference pursuant to Governor Newsom's Executive Order N-25-20.

Chairwoman Olsen announced that this meeting will be held in accordance with the Governor's Stay at Home Executive Order N-33-20 and will not include in person public attendance. She reviewed the options for the members of the public to observe the meeting and provide comments to the Board via email or telephone as listed on the first page of the agenda.

A moment of silence was held for Stanislaus County Sheriff's Department employee Sergeant Bruce Mitchell.

Alexxandria Paige inquired about the requirements regarding education of law enforcement and mental health services.

Invocation was given by Michael Douglass with Advancing Vibrant Communities.

CEO Hayes and Public Health Officer Dr. Vaishampayan provided an update related to the 2019 Novel Coronavirus (COVID-19) emergency and essential services in Stanislaus County and discussed the statewide opening of 12 new sectors allowed for option to open for counties with variances.

Thomas Tyler voiced concerns regarding masks not being mandated to wear in public.

Kim Martinez inquired about the reopening of public swimming pools.

Miguel Donoso expressed concerns regarding the timing of publishing the Board of Supervisors agenda.

Wendy Byrd expressed her condolences for the family of Bruce Mitchell and requested a moment of silence for George Floyd. She shared concerns of the use of force by law enforcement and suggested a Virtual Town Hall Meeting, and expressed concerns regarding COVID-19 testing for protestors and thanked the health services workers.

Monica Johnson shared concerns regarding mental health services affecting youth and future funding impacts.

Amy Villalovos expressed concerns regarding mental health budget cuts for youth.

Kyndal Harkrader shared concerns regarding racial equality and engagement of City and County officials. She also inquired about the CARES Act funding.

Steve Allen shared concerns regarding civil unrest and police brutality and asked the Board to make a clear statement as to what side they are on.

Clara Silva inquired about the Board's views of reallocating funds from law enforcement to agencies that are better equipped to deal with mental health issues and review of resources for allocating funds to disadvantaged parts of the County.

Jonathan Grammatico inquired about what the County is doing to help with the racial disparities of COVID-19, free COVID-19 testing for peaceful protestors, and shared concerns regarding law enforcement funding.

Rachelle Edmonds inquired about building a bridge between the community and law enforcement and asked how we can create more community involvement with law enforcement.

Eric Green shared concerns regarding law enforcement and the safety of protestors. He also inquired about funding for mental health.

Leonela Mota expressed that not all community members have the same opportunities and the need to bridge the community and leadership. She also shared safety concerns in Oakdale.

Gregorio Tabera shared concerns about available resources the campus of CSU Stanislaus.

Adriana Ushishba voiced concerns about homeless and the hiring of more law enforcement. She also shared concerns about the safety of protestors.

Martha Caroltin Magana voiced concerns regarding episodes of violence with law enforcement and the lack of transparency, and masks not being required in the County Courthouse.
