Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

January 11, 2022

Invocation was given by Imam Ahmad Kayello with Islamic Center of Modesto.

Chiesa/Grewal unan. Elected Supervisor Withrow as the Chairman and Supervisor C. Condit as the Vice-Chairman of the Stanislaus County Board of Supervisors for 2022. 2022-0001

Chairman Withrow recognized Supervisor Chiesa as the 2021 Chairman of the Board and thanked him for his leadership.

Jan Schmidt presented the Stanislaus County Law Library 2020-2021 Annual Report.

CEO Hayes, Public Health Officer Dr. Vaishampayan, and Director of the Health Services Agency Mary Ann Lily-Tengowski provided an update of the 2019 Novel Coronavirus (COVID-19) Emergency and Essential Services in Stanislaus County.

Chairman Withrow acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Steven Morrow shared his experience with the launch of the START real time bus information and stated that the first week was a little bumpy but this week it had improved. He shared concerns regarding the proposals and funding for a new downtown ballpark, however he supports any zoning variance that needs to be approved.

Yvonne Reynolds read an article that was published in the SFGATE that discussed why the City of Oroville, CA declared their city as a constitutional republic. She spoke about the constitution and shared concerns regarding elected officials not listening to the constituents. She read the definition of a State of Emergency and stated she was confused why we are still in a State of Emergency.

Janet Betcher spoke regarding the invocation given and stated those words were important and meaningful. She shared she was impressed with the CEO's remarks this morning. She acknowledged the HSA staff and stated they must be really stressed out.

Joni Griepp spoke on behalf of her kids and all kids. She stated that CA was the last state to reopen schools and the only state that is requiring vaccine mandates for schools. She shared concerns regarding policies and guidance from the California Department of Public Health (CDHP). She also expressed concerns for children masking for eight hours a day.

Ashley Miguel expressed concerns regarding the lack of education in our community regarding COVID-19. She stated we should not be testing anyone and everyone. She shared that the emergency rooms are strained, and that doctors' offices are not accepting COVID-19 patients. She thinks more can be done.

Keryn Whitlow shared she brought copies of the constitution with her today. She stated she was happy to hear CEO Hayes talk about a new COVID-19 phase today. She shared concern about children's mental health and asked when people are going to talk about it. She said she hopes in Phase 3 we can bring long term solutions, not reactionary. She believes at a local level we can do more.

Janet Rocha thanked Supervisor Grewal for helping her recently with a situation. She shared concerns regarding an article she read from the SF Bay Area about healthcare workers that are COVID-19 positive but asymptomatic being able to return to work. She asked the Board to listen to the community.

Maritza Romero, mother of 8, shared concerns regarding our youngest being the most vulnerable population. She read an article from the Thomson Reuters collection from 12/28/2021 regarding vaccine affects on children. She stated that children are helping to make heard immunity and children are the least likely to contract it.

Emerson Drake shared concerns regarding people not masking and the unvaccinated. He stated that people come to this Country for stronger laws.

Joni Griepp stated that freedom of speech is so important, and that discrimination is ugly.
