Invocation was given by Pastor Jeffrey Woods, with First Christian Church.

Chairman Withrow acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Rebecca Harrington spoke regarding the need for infrastructure in the South Modesto area. She urged the Board to use American Relief Plan Act (ARPA) funds for curbs, sidewalks, and flood controls in this area. She asked the Board to consider her request and to take the next steps to be annexed into Modesto.

Susan Padilla voiced concerns regarding her daughter's experience with Community Housing and Shelter Services (CHSS). She asked the Board for help with this issue.

Miguel Donoso provided a letter to the Board and shared concerns regarding the Stanislaus Homeless Alliance Board and conflict of interests regarding funding received from State.

Alicia Escamilla spoke regarding the need for infrastructure of South Modesto and shared she has spoken with residents about the needs in this area.

Steven Morrow shared concerns regarding various agencies and commissions still conducting public meetings via video conference. He stated that boards that continue to offer remote only access need to allow the public to attend in person.

Jim Bishop spoke regarding lead being a neurotoxin. He noted that small planes use leaded fuel and we should act quickly to ban the sale of leaded fuel at the Modesto City-County Airport - Harry Sham Field.

Jody Smith noted that she has worked for Stanislaus County BHRIS for 5 years and is an SEIU member. She shared concerns regarding wages for this bargaining unit.

Kandace Weyhrauch spoke regarding the City of Patterson approving new development without the infrastructure and school facilities to support this growth. She expressed concerns regarding access to and from I-5 and asked the Board to make the South County Corridor a priority.

Joni Griep shared concerns regarding children being required to be masked at school.

Jessica Climer expressed concerns regarding her son's school day being filled with COVID-19 talk and teachers stopping instruction to tell children to put their masks on. She stated we need to do something for our children, and we need to fight for them.

Jolene Corkwell stated her son is a freshman and was denied in-person learning recently for participating in a peaceful protest of the mask mandate. She asked for schools in this County to give children a choice on whether to wear a mask.

Keryn Whitlow voiced concerns regarding children in the County being discriminated against for not wearing masks. She shared children are not being treated equitably and that schools can implement accommodations.
