Convened at 5:34 p.m. for Special Session

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

Renee Crawford, Social Worker and SEIU 521 member, shared concerns regarding the patient to mental health provider ratio and retention of employees. She noted she submitted two public record requests to Human Resources. She asked the board to hear them, pay them fairly and value their employees.

Karyn Clark, BHRS Specialist and SEIU 521 member, shared concerns regarding employee retention and the increased need for mental health services. She asked the board for help in resolving the issues of retention, hiring, and to please consider the community.

Jim Bishop shared concerns regarding the Modesto Airport only selling leaded gas. He spoke regarding the Sheriff's Department's plane flying around his neighborhood and the leaded fuel being sprayed and disturbing his neighborhood.

Julie Key, Mental Health Clinician and SEIU 521 member, shared concerns regarding retention and staffing crisis for their union. She urged the board to help with this overwhelming issue.

Margaret Countryman voiced concerns regarding her 2017 appeal process of a neighbor's second story building permit.

Miguel Donoso expressed concerns regarding the Turlock Mayor and City Manager leaving before he could speak about the City of Turlock removing the Home Investment Partnerships Program (HOME) Funds. He shared concerns regarding the appointment process of two Assistant Executive Officer's in the CEO's Office.

Susan Padilla shared concerns regarding Stanislaus County Community Housing and Shelter Services. She also expressed concerns regarding the new Sheriff's substation in Salida.

Rebecca Harrington voiced concerns regarding the lack of street lighting in the area of South 9th Street and Hosmer Avenue and the need for pole lighting in this area. She shared concerns regarding the closure of the 7th Street bridge and inquired about the mitigation efforts of Caltrans and the County for traffic in this area. She also noted that there was a cleanup at 719 St. Anthony's Street and that property is now a nuisance again.

David Cheek spoke regarding a nuisance issue at his neighbor's property at 4442 Jennings Road and asked for help and offered to be part of the solution to clean up this property.

Joe Nunes, longtime resident of the Westport Community, voiced concerns regarding the nuisance and illegal activities at 4442 Jennings Road.

Ross Lee, Attorney and Westport Community Board Member, shared concerns regarding a nuisance and safety concerns at 4442 Jennings Road and asked the Board for help.

Supervisor Chiesa noted that last week he joined a ride along with the Community Assistance Response Engagement (CARE) Team and acknowledged the progress they have made in finding housing for high distress individuals and noted the success this team has made in helping this priority population.
