Susan Padilla shared concerns regarding Community Housing and Shelter Services (CHSS). She also spoke regarding the approval of the General Plan Amendment (GPA) and Rezone Application No. PLN2019-0045, Beeler Development in the community of Salida.

Margaret Countryman voiced concerns regarding her appeal of the City of Modesto's Board of Zoning Adjustments decision concerning a neighbor's second story addition.

Zachary Drivon shared the effects on the legal cannabis industry over the past two years regarding the collection of impact fees. He requested the impact fee rates be restructured and asked the Board to allow the opportunity for these businesses to strive.

Celestia Love shared concerns regarding her son's mental health and her interactions with the BHRS and the Sheriff's Department when trying to obtain help for him. She expressed she is here to try and educate the police and behavioral health.

Alicia Escamilla spoke regarding a signed petition she shared with the Board in support of ARPA funds being used for infrastructure in the South Modesto area.

Sherine Richards spoke on behalf of Aspiranet and shared the resources this agency provides.
