Invocation was given by Steven Morrow.

Catherine Bender from CSA received her 30-year Employee Service Award.

Lori Williams, Associate Director of Public Health, recognized the Stanislaus County Medical Reserve Corps volunteers.

Chairman Withrow acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Debbie Martinez, representative of the disadvantaged community and member of We "R" La Raza Parents Union, expressed concerns regarding educators. She shared she is the voice for the voiceless and asked the Board for help.

Jorge Martinez voiced concerns regarding the neglected neighborhoods of south Modesto, westside and airport district. He requested Crows Landing Road be renamed to Cesar Chavez Road.

Alicia Escamilla spoke regarding the Parklawn and south side infrastructure and shared she has gathered signatures to improve these areas. She shared she is planning a community meeting and hopes the Board will attend.

Joni Griepp shared concerns regarding SB871 and the effects on schoolchildren.

Jim Bishop shared concerns regarding the Sheriff's Department plane flying around his neighborhood using leaded fuel. He asked that they reduce the number of flights.

Samuel Bosshardt expressed concerns regarding the Stanislaus Regional Transit (StaRT) buses still requiring masks for riders. He asked if there is an exit strategy for mask wearing on Stanislaus Regional Transit (StaRT) buses.
