Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

April 26, 2022

Invocation was given by Pastor Michael Douglass, with Advancing Vibrant Communities.

A moment of silence was held for former Stanislaus County Parks Director William (Bob) Gregory.

Christine Huber, Director of CSA and Lori Schumacher, Program Director for the Center for Human Services, gave a presentation regarding April 2022 as Child Abuse Prevention Month in Stanislaus County.

Rick Santos, StanCERA Executive Director, gave a presentation to the Board regarding the Stanislaus County Employees' Retirement Association (StanCERA).

Katherine Borges voiced concerns regarding a variety of topics including: the status of a public records request concerning the Salida Sheriff's Substation, the need for the County to improve communication with the community, sex trafficking occurring in Salida, weeds along highway 99, and illegal dumping. She requested another sign for the Salida Substation and to fix the County sign located by the Salida Library.

Debra Harper spoke regarding her suspension from the County Libraries, and that her phone was stolen.

Steven Morrow spoke regarding StanCERA's presentation and shared that six figure pensions are not common. He stated that inflation is the cruelest tax of them all.

He shared that Public Works fixed a pothole that he reported by using the new Stan Connect app. He also shared that the San Joaquin Valley Air Pollution Control District is having a Free Smog Repair Event at John Thurman Field, 601 Neece Drive, Modesto, CA 95351 this Saturday, 04/30/2022 from 8:00 a.m. – noon.

Chairman Withrow reported he, along with Supervisors Chiesa and B. Condit attended the Grand Opening of the Salida Sheriff's Substation on Saturday, 04/16/2022. Yesterday, he attended the Governor's CARE Court roundtable at the Capitol.

Supervisor B. Condit reported that he participated in the Valley Home community clean-up on Saturday, 4/16/2022 and two dumpsters were filled.

Supervisor Grewal reported that he hosted the Gregori High School Prom at his property this past weekend.

CEO Hayes reported that the Board sent a letter of opposition regarding AB 2201, which concerns groundwater extraction and noted that staff is tracking this bill. He spoke regarding AB 481, which concerns the acquisition and use of military equipment by local law enforcement agencies, and reported that the County has begun the approval process to comply with this legislation. He shared that the County is working on identifying this equipment and will come before the Board by the end of the year for consideration.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
