THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS STATE OF CALIFORNIA

Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday June 14, 2022

Invocation was given by Rev. Eissabake, with St. John Assyrian Presbyterian Church and Chaplain for Memorial Hospital.

Dr. Papasozomenos, Assistant Public Health Director and Lori Williams, Associate Director Public Health, presented a quarterly public health update to the Board.

Blake Seagraves spoke regarding his family cannabis business, Uncle Budd's Nursery. He voiced concerns regarding the different tax rate for cannabis industries vs. non-cannabis industries. He recommended that a sliding scale be used instead of a percentage for tax rates.

Frank Edwards, Owner of Prem Gen Corp., a cannabis nursery (Uncle Budd's Nursery) spoke regarding the development agreement they entered into with the County. He shared that the market is flooded with illegal product which has impacted his business.

Barbara Nunez, IHSS provider, shared that she cares for her 26-year-old disabled daughter. She noted that there is an increased need for home care providers and a difficulty in meeting this need due to their wages. She requested that the Board approve an increase of their wages.

Terry Walker Dampier, member of the UDW, spoke regarding the importance of IHSS providers and the need for a wage increase due to rising costs of living.

Gwendolyn Byrd spoke regarding the salary of the IHHS caregivers and the high cost of rent in this County. She noted the important work IHHS providers perform and spoke in support of a wage increase.

Joni Griepp spoke regarding today's Public Health presentation. She referred to a study concerning the natural immunity found in school age children for COVID-19. She noted the increase in COVID-19 cases and shared that the counties with the highest COVID-19 rates also have the highest vaccination rates.

Joseph Monterosso voiced concerns regarding a dirt strip adjacent to his property on Horsehoe Road and provided handouts to the Board. He requested that the County close this dirt strip, and to respond to his request.

Miguel Donoso shared that residents have difficulty attending Board of Supervisors meeting. He spoke regarding the low public attendance at the community meetings being held regarding the \$50 million the County has set aside for infrastructure improvements in unincorporated communities. He voiced concerns regarding the locations of the community meetings and suggested that the County use schools or churches at meeting locations.

Megan Short shared concerns that the suicide rates of children in this County are not being tracked. She noted that we have a mental health crisis and our children are greatly affected by this.
