Regular Session All Supervisors Present Pledge of Allegiance to the Flag **Tuesday**

August 30, 2022

Invocation was given by Pastor Jeff Woods, with Barnabas Leadership Foundation.

Chairman Withrow acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Joseph Monterosso noted that the County was served with a lawsuit yesterday. He requested that the Board help speed up the process of resolving the issue with a dirt road adjacent to his property. He spoke regarding veterans and shared that if the County put together a small fund for deserving veterans that he would match it dollar for dollar. He voiced concerns about the safety of the dirt trail next to his property and the potential for a child to drown in his pool. He noted that he is waiting for County Counsel to respond to two public records requests.

Michelle Burke shared that her neighbors recently met regarding the Old Colony Road trail and feel that the road is safe and should not be gated off. She noted that a neighbor who has lived on Horseshoe Road for 75 years does not think there has ever been an incident on the trail. She voiced concerns regarding an anonymous letter that neighbors received from The Oakdale Project which stated neighbors were misled about the safety of the trail and she provided a copy of the letter to the Board.

Gail Altieri spoke regarding taxpayer money that was spent due to the Sheriff's office responding to numerous calls over 2-3 weeks regarding Old Colony Road.

Jim Bishop shared that a 4-year-old boy was injured by a driver hit-and-run on Donald Street located in the Robertson Road neighborhood. He noted there is no stop sign on Donald Street. He requested that the County section off Donald Street at Marlow St. and Hancock St., install plastic bollards to stop traffic, and add bolt down speed bump to create a safer neighborhood.

Blanca Rivera, IHSS provider, requested that the Board approve a wage increase. She spoke regarding the vacancy rate for County employees and the recent raise given to employees. She noted that IHSS providers spend their wages locally.

Chuck Walker, Sr., shared that IHSS providers care for low-income seniors and individuals with disabilities in our community which makes it possible for them to stay in their homes. He spoke regarding the 5% raise and bonuses approved by the Board for all County employees. He noted that IHSS providers are essential workers and are asking for: a \$2.11 wage increase, one-time hero bonus, expanded access to dental and vision care, and life insurance benefits. He mentioned that the County pays 16% of the IHSS provider wages. He shared there are not enough providers in the County and spoke regarding a 2019 audit of the Stanislaus County IHSS program which reported that approximately 500,000 hours of needed care is going unmet. He asked the Board to pay IHSS providers a livable wage.

Josephine Carson noted that she and her husband are both members of the California Alliance for Retired Americans. She spoke in support of a wage increase for the UDW employees / IHSS providers. She

spoke regarding the challenges of caring for a disabled individual and shared her family's experience of caring for her grandmother. She noted that seniors want to live independently in their homes and that it is less expensive and better for their well-being. She shared that IHSS providers save the government money and they are essential workers.

Miguel Donoso voiced concerns regarding the job description of the new Diversity, Equity, and Inclusion (DEI) Manager position. He spoke regarding the importance that the individual hired for this position should be familiar with the needs of the low-income residents who live in the underrepresented and underserved minority communities.

Cynthia Homen, Patterson City Council member, noted that her mother was a caregiver. She spoke in support of a raise for the UDW employees and the IHSS providers.

Astrid Zuniga, care provider for her adult child, noted that she is participating in the Stanislaus 2030 meetings. She spoke regarding redefining economic success and that homecare workers are not part of the inclusion. She shared caregivers are the fastest growing workforce in the nation, and that we do not have the means to care for all the seniors and people with disabilities in the community. She noted that many of the IHSS providers are women of color, and they should be respected for the work they do with a living wage.

Stacy Garcia spoke regarding the difficulty in caring for her disabled mother. She shared her niece makes more money than her working at Olive Garden. She spoke regarding the increased cost of groceries and spoke in support of a wage increase.

Will Kelly, Executive Director of the North Valley Labor Federation, spoke regarding the current labor negotiations with UDW for IHSS providers and noted it is about dignity and respect. He spoke in support of a wage increase for IHSS providers and noted the important life-giving work they do.

Mike Thiry spoke regarding public comments made at the 8/16/2022 Board meeting concerning the danger of motorized vehicles and horses being on the same road. He noted that horses are used by many law enforcement agencies for crowd and traffic control. Horses are used at the Oakdale Rodeo and used in New York City as mounted police. He shared that there have been hayrides on Halloween for many years in the dark on Old Colony Road and there has never been a recorded accident. He noted that this road is a great asset to their community.

Debbie Martinez spoke regarding children being victimized in schools. She shared children deserve safe, secure, and peaceful schools. She spoke regarding a teenager who recently drowned at Turlock High School. She also spoke regarding the school to prison pipeline and noted that she will continue to fight for the disadvantaged student population.

Sebastian Jones noted that everyone is getting older and we will all need a caregiver at some point. He spoke regarding the pay raise given to County employees and spoke in support of a wage increase for UDW members.

Terry Walker-Dampier spoke in support of a living raise for UDW caregivers. She noted that the wages they receive they spend in the County. She spoke regarding the important work that UDW caregivers provide.

Yesenia Cuevas with the California Alliance for Retired Americans, a senior advocacy organization, noted that by 2030 older adults will compromise 25% of the population in California. She spoke

regarding the important work performed by IHSS providers and the increased number of caregivers who will be needed in the future. She asked the Board to do what is right by the IHSS workers and give them a raise.

Tim Pflueger, IHSS worker, shared that he cares for his daughter. He noted that being in a nursing home is not the same as being cared for at home.

Dela Perales gave examples of how everyone needs help, and we all need to work together. She shared that IHSS providers do all the work themselves. She spoke in support of a living raise for the IHSS providers.

Teresa Tovar, IHSS caregiver, spoke regarding the bill going to the Governor regarding fast food worker rights and she asked about the caregiver rights. She shared the important work that IHSS providers perform. She asked the Board to respect their work and the rights of the elderly and disabled.

Supervisor Chiesa reported that he, along with Supervisor Buck Condit, StanCOG Executive Director Rosa Park, and Modesto City Councilmember Rosa Escutia-Braaton, attended the one-day 2022 Mobility Transportation Summit last week.

CEO Hayes reported that Stanislaus County is included with the first cohort of counties for the SB-1338 Community Assistance, Recovery, and Empowerment (CARE) Court Program and \$26 million has been identified for the first cohort of counties. He also reported that the County sent a letter requesting the Governor veto AB 1951 which would increase tax exemptions for purchases of manufacturing products. The County continues to oppose this bill which would result in a \$2 billion reduction in local revenues throughout the State.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
