Invocation was given by Hermana Liddiard, from the Church of Jesus Christ of Latter-Day Saints.

Joseph Monterosso shared concerns regarding the annual Horseshoe Halloween Hayride and provided handouts to the Board. He also voiced concerns regarding his neighbor and the dirt strip adjacent to his property.

Martin Lourd spoke regarding the New California State movement. He shared he was putting the County on notice that the State of California is in constitutional default and read a statement of intent.

Matthew Davila spoke in support of the New California State and continued to read the statement of intent regarding New State California.

David Avila spoke in support of the 51st State, the New California.

Nathan Moore spoke in support of the New California State and continued to read the statement of intent regarding New State California.

Patricia Shaefer spoke in support of the New California State and continued to read the statement of intent regarding New State California.

Mylinda Mason shared handouts with the Board and spoke in support of the New California State.

Nathan Moore, spoke for son Alex Moore, in support of the New California State and continued to read the statement of intent regarding New State California.

Cheryl Aseltine spoke in support of the New California State and continued to read the statement of intent regarding New State California.

Martin Lourd, local government teacher, spoke about our founders and this movement of the New California State.

Zach Drivon thanked the Board, County Counsel and CEO for all the work they do. He spoke regarding the current Development Agreements with Jayden's Journey and The People's Remedy. He shared concerns regarding declining revenues, flat fees and the potential closure of the cannabis programs. He asked the Board for immediate suspension of the flat fees.

Irene Pedro worked for IHSS for 20 years and spoke in support of a wage increase for IHSS workers.

Astrid Zuniga, provider for adult son for 14 years, shared concerns regarding previous wage increases for IHSS providers and the need to renegotiate every few years. She spoke in support of a wage increase for IHSS workers.

Jason David, owner of Jayden's Journey, shared concerns regarding the current Development Agreement. He spoke in support of a wage increase for IHSS workers.

James Martin spoke in support of the New California State. He encouraged everyone to check out the website <u>www.newcaliforniastate.com</u>.

Terry Walker-Dampier voiced concerns regarding IHSS wages and shared several caregivers have quit in order to go to school to become CNA's due to higher hourly wages. She spoke in support of IHSS wage increase and asked the Board to put people first not the dollar bill.

John Adams shared concerns regarding IHSS wages and shared fast food restaurant workers earn higher wages than IHSS workers. He voiced concerns regarding the inability to receive the necessary medical supplies for his daughter. He supports a wage increase for IHSS workers.

Mark Ponticelli, owner of People's Remedy, thanked the Board and staff and acknowledged it is a pleasure working with them.

Gloria Abarca spoke in support of a wage increase for IHSS workers. She shared concerns regarding her daughter not getting paid enough or being allotted enough hours to be her caretaker.

Jovita Tovar, provider for daughter, spoke in support of a wage increase for IHSS workers and shared she does more than a registered nurse. She voiced concerns regarding IHSS workers having to pay out of pocket for transporting patients to doctor appointments.

Benelba Barrera Alonzo, provider for son for 26 years, spoke in support of a wage increase for IHSS workers. She shared concerns regarding increase in costs in the economy and out of pocket expenses for travel for out of area doctor appointments. She expressed they are not asking for much, but it would help.

Lori Norwood, provider for daughter, spoke in support of a wage increase for IHSS workers. She voiced concerns regarding monthly wages as a caretaker versus her monthly wages when she worked as a Case Manager for the County.

Selena Norwood shared concerns regarding the lack of wages for IHSS workers. She voiced concerns regarding the cost of living going up. She asked the Board to look at what IHSS is bringing to the table.

Margarita Arteaga, IHSS provider, shared concerns regarding the lack of wages and the affects COVID has had on her family. She supports a wage increase and shared she works 12-14 hours a day and still struggles financially.

Sarah Johnson asked the Board why IHSS providers cannot receive a cost of living wage. She expressed she receives IHSS services and is very thankful for these providers and supports a wage increase.

Sebastian Jones spoke in support of a wage increase for IHSS providers. He shared concerns regarding the length of time the negotiation process has taken. He requested a \$4.00 wage increase for IHSS providers.

Della Perales shared concerns regarding the proposed .75 cent wage increase for IHSS providers. She voiced concerns regarding the length of time the negotiation process has taken and that providers will not receive retroactive pay. She stated it's time to stop negotiations and provide IHSS providers a livable wage.

Miguel Donoso shared concerns regarding the New California State.

Petri spoke in support of a wage increase for IHSS providers.

Marina Luna Gaitan, provider for adult son, shared concerns regarding wages for IHSS providers. She supports a wage increase for IHSS providers.

Lucia, provider for adult daughter, shared concerns regarding providing 24/7 care for her daughter but not receiving compensation for 24/7 care. She supports a wage increase for IHSS providers.

CEO Hayes reported that the State Department of Finance has released the first quarter revenues and they are far below what was expected. He shared that the Governor ended the COVID-19 State of Emergency effective February 2023. He noted the County ended our local emergency a few months ago. He shared the annual visit with Shaw Yoder is Wednesday, 12/07/2022, to help develop the County's 2023 Legislative Platform.
