Chairman Channce Condit delivered the 2023 State of the County Address.

Commendations were presented to April Lester (District 1); John Peter "Pete" Sward (District 2); Sebastian Jones (District 3); Christy Walker (District 4); Helen Florez (District 5) as the 2023 Stanislaus County Outstanding Senior Citizens of the Year in celebration of Older Americans Month.

The 2023 Stanislaus County Recycling Poster Contest winners received their awards.

Miguel Donoso provided a press release to the Board regarding underserved residents' concerns regarding the Economic Development Strategy 2023-2028. He also noted that he has not received a response to his requests regarding the Economic Development Committee. He voiced concerns regarding the Economic Development Committee's process.

LaPrice Reynolds asked the Board for support in adapting an equity program in the County, specifically for cultivation.

Lisa Marx, representative for the Carpenter's Union, shared a story regarding an apprenticeship opportunity that the union provided her. She urged the Board to consider responsible contractors that pay area standard wages and offer these apprenticeship programs on future projects.

Alex Gergalo, member of the Carpenter's Union for 16 years, shared this union provides the opportunity to earn a living wage and allowed him to enter as an apprentice. He asked the Board for their support in the apprenticeship program and to support the contractors that are registered training agents with the State and pay the area standard wages and benefits.

Dianne Love, thanked the Board for their continued help. She shared concerns regarding her and her son being unable to gain legal guardianship of her grandson.

Withrow/B. Condit unan. **7.A.1 Amended** the minutes of 05/02/2023 to include Miguel Donoso's request under public comments for technical assistance in regards to the Draft Comprehensive Economic Strategy Report for 2023-2028; and, approved the minutes as amended 2023-0214

Chiesa/Withrow unan. 9.1 Declared an emergency in accordance with California Public Contract Code Section 22050 for emergency temporary repairs to Del Puerto Canyon Road 13 Miles west of Interstate 5; approved staff's recommendation to act in accordance with California Public Contract Code Sections 20134 and 22050 to make the immediate temporary repairs to Del Puerto Canyon Road; made the following findings: (a) the repairs are necessary to ensure the safety of the traveling public and to prevent the loss of essential public services; (b) the emergency will not allow for the delay that would result if the project were competitively bid, and the action to immediately repair the impacted road facility on an emergency basis is necessary; (c) based on the substantial evidence to be set forth in the minutes, that due to the nature of the emergency a delay for competitive bidding cannot be permitted; directed the Director of PW, or designee, to serve as the Project Manager for all aspects of the project; authorized the Project Manager to procure equipment and supplies, and to negotiate and execute contracts needed to repair the roadway, without giving notice for bids, so long as they are within the Department's approved budget; and, required PW to report to the Board on the status of the emergency project at its next regularly scheduled meeting and every 14 days thereafter until the repairs are completed, as required by Public Contract Code section 22050(c)(1) – PW 2023-0229

Tina Rocha, Assistant Executive Office, noted that staff are developing strategies to do additional outreach and seek community input to bring back to EDAC for consideration.

CEO Hayes reported that the Governor's May Revised Budget has been released.
