Invocation was given by Pastor Lyn Crase from Emanuel Lutheran Church.

Baljit Atwal, Director of Child Support Services, Lisa Clifton, Assistant Director, and Michelle Lopes, Manager, gave a presentation regarding August 2023 as Child Support Awareness Month in Stanislaus County.

Sheriff Dirkse and Sergeant Craig Osmonson provided an update on the Stanislaus County Sheriff's Office Air Unit. The Sheriff recognized Deputies Tony Winstead and Andrew Nickkel and presented them with the Sheriff's Department Life Saving Awards.

Ramon Rodriguez spoke regarding the death of Christine Chavez which recently occurred at Beard Brook Park. He voiced the need for services for homeless individuals including temporary shelters, transitional housing, and financial stability. He also disagreed with comments made by a public member during a Board meeting last month who was advocating for a return to one day voting.

Debra Harper spoke regarding her experiences with law enforcement and the courts, and shared that she has been manipulated.

Nasson Sanchez spoke regarding the importance of National Night Out events in the community and invited the Board to attend.
