Invocation was given by Reverend Edward Eissabake with St. John's Assyrian Evangelical Presbyterian Church.

Lisa Mantarro Moore, Executive Director of the Family Justice Center of Stanislaus County, gave a presentation on services and outcomes.

Sofia Vivo gave a presentation regarding the loss of her sister Bella due to Fentanyl poisoning. Chairman C. Condit presented Sofia, along with staff from BHRS a resolution proclaiming 08/31/2023 as Overdose Awareness Day in Stanislaus County.

Miguel Donoso voiced concerns and noted he has not received a response to his request regarding the Economic Development Committee. He also shared concerns regarding a conflict of interest for three members on this Board.

Debbie Martinez, active community activist and founder of "We "R" La Raza Parents Union", spoke regarding the two presentations this morning. She voiced concerns regarding a Modesto Bee article published on 08/02/2023 regarding Modesto continuing to struggle in education, according to a recent report that ranks it the fifth least educated among the 150 largest U.S. metropolitan statistical areas.

Katherine Borges provided a handout to the Board. She shared concerns regarding a previous request she made for sidewalks in downtown Salida. She voiced concerns regarding the Salida Community Development Plan and encouraged the County to do the Environmental Impact Report (EIR) in house and create a Community Services District (CSD) for Salida.
