Diane Kroeze, homeless advocate, voiced concerns regarding the homeless including safe sleeping.

Miguel Donoso voiced concerns and noted he has not received a response to his request regarding the Economic Development Committee. He also shared concerns regarding a conflict of interest for three members on this Board.

Jose Ramirez, representative for Animiria Madrigal, shared a handout with the Board. He shared concerns regarding her application for a permit to use her property as a public event center. He asked the Board to direct CEO to work with County Counsel and staff to address this issue.
