Invocation was given by Carlos Gonzalez with City Ministry Network.

Sara Lytle-Pinhey provided an update on the Stanislaus Local Agency Formation Commission (LAFCO).

Lynelle Solomon, Homeless Advocate, shared concerns regarding a sweep at a homeless encampment on 7th Street. She shared the need for safe camping and asked the Board to work with the City of Modesto to resolve the homeless problem.

Ron McMurtry voiced concerns regarding the recent presentation regarding AB 481 and asked that the Sheriff's Department start keeping track of when the military equipment is being used. He shared he is impressed with local transparency and appreciates that department heads are required to make reports.

Zeff Solomon shared concerns regarding the homeless encampment on 7^{th} Street. He asked the County to work with the City to find a solution for homelessness.

Daniel Wendall shared he participates on the Mental Health Board and is interested in learning the laws and getting involved with the homeless. He thanked the Board for being involved.

CEO Hayes noted that the originally scheduled update on the analysis of implementation of SB 43 regarding conservatorship that was scheduled for 01/30/2024 has been delayed and rescheduled for 02/06/2024. He reported that the 2024-2025 Governor's January Proposed Budget was released at the beginning of the month and noted it is difficult at this stage to know exactly what the budget is going to look like. He provided an overview regarding the impact of this budget and the deficit based on the County's preliminary review.
