*Pursuant to Government Code §54953(b), this meeting included a teleconference location at The Mayflower Hotel, Delaware Board Room, 1127 Connecticut Avenue, NW, Washington, D.C. 20036. Supervisor Chiesa attended the Regular Session via teleconference. The public was allowed the opportunity to address the Board at this teleconference location pursuant to Government Code Section §54954.3. All votes during the teleconferencing session were conducted by roll call vote. The teleconference location was accessible to the public and the agenda was posted at the teleconference location 72 hours before the meeting.

Convened at 6:00 p.m. for Special Session

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

Invocation was given by Russ Gagon from the Church of Jesus Christ of Latter-day Saints.

Commendations were presented for Pamela Kelly (District 1); Neil “Skip” Young (District 2); Karen Princevalle (District 3); Patricia Glatke (District 4); Pat Maisetti (District 5) as the 2024 Stanislaus County Outstanding Senior Citizens of the Year in celebration of Older Americans Month.

The 2024 Stanislaus County Recycling Poster Contest winners received their awards.

Tom Stadelmaier, Executive Director of StanCERA, Stan Cronwell, Investment Officer, and Kellie Gomes, Business Operations Manager, gave an update on the Stanislaus County Employees’ Retirement Association.

Milt Trieweiler shared concerns regarding people not following the facts and reality of climate change. He also voiced concerns regarding a weapons problem recently.

Sabastian Jones voiced concerns regarding the care his wife received at the Paradise Medical Clinic and shared he learned that the County is moving away from providing services at this location. He expressed support for the recipients of the Senior Citizens of the Year.

Bianca Lopez, with Valley Improvement Projects, spoke regarding the Recycling Poster Contest Winners presentation today. She voiced concerns regarding Covanta and the urgency to close the incinerator. She

spoke regarding SB54 -Plastic Pollution Prevention and Packaging Producer Responsibility Act. She shared the need to develop a zero-waste plan, create a local task force, and secure funding.

Eleanor Chase shared concerns regarding the inability to receive cat vaccinations at the Stanislaus Animal Services Agency. She also voiced concerns regarding the lack of availability of appointments for dog vaccinations. She shared she would like to see the return of the Saturday cat and dog vaccination clinics. She also shared that animal services needs to hire a receptionist and receive more funding for the agency.

Chairman Grewal reported last week he and CEO Hayes participated in a few roundtables with the President of the Senate Pro Tem and CEO staff spoke about Bioeconomy, Agriculture, and Manufacturing (BEAM) Circular, Stan2030.

CEO Hayes provided an update regarding the Governor's May Revise Budget. He noted there is a risk for service level reductions, however he acknowledged it is too early to tell what will occur. He reported that the public hearing for the Proposed Budget for Budget Year 2025, and another update on the Governor's May Revise Budget, will occur at the 06/04/2024 Board Meeting.

Supervisor Chiesa reported that he attended the Veterans Advisory Commission Meeting yesterday. He shared Bruce Wardee finished his stint on this board and Melissa Wanty-Osuna has stepped down.
