Invocation was given by Pastor Joe Duran with City Ministry Network.

Supervisor C. Condit recognized Juan Diego Gonzalez as the Recipient of the League of United Latin American Citizens Internship.

Sheriff Dirkse and Lieutenant Dimberg gave an update on the Stanislaus County Sheriff's Office Threat Assessment Center.

Steven Morrow spoke regarding an item on last week's agenda concerning Google Translation. He shared he tried out this interpretation system and it worked well; however, he noted it cannot download documents larger than 10 MB.

Carl Wood, CEO of Vocational Coaching and Development Institute, which is a day program for people with developmental and intellectual disabilities, spoke about the services they provide. He thanked the Board Members who toured the facility located at 1125 I Street, Modesto.

Miguel Donoso voiced concerns regarding the recommendation made last week regarding bilingual services. He shared concerns regarding a conflict of interest for CEO Hayes and County Counsel Boze.

Bryan Evitt shared concerns regarding the health and safety at the County jail. He also voiced concerns regarding claims submitted to the County.

Chairman Grewal acknowledged receipt of written public comments. He noted that all written public comments were distributed to the members of the Board of Supervisors.
