Condit unan. 6.1 Conducted a public hearing to consider the Planning Commission's Recommendation of denial for Rezone Application No. PLN2023-0065 – Caloy Company, LP, a request to rezone 14.64± acres from Planned Development (P-D) (312) and General Agriculture (A-2-40) to a new P-D, to allow for the expansion of an existing nut oil and cattle feed processing facility, located at 5425 Montpelier Road, between E Keyes Road and E Monte Vista Avenue, in the Denair area; adopted the Negative Declaration pursuant to the CEQA Guidelines Section 15074(b), by finding that on the basis of the whole record, including the Initial Study, and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Negative Declaration reflects Stanislaus County's independent judgment and analysis; ordered the filing of a Notice of Determination with Stanislaus County Clerk-Recorder's Office pursuant to Public Resources Code Section 21152 and CEQA Guidelines Section 15075; finds, based on the discussion in the agenda item, and the whole of the record that: (a) the project is consistent with the overall goals and policies of the Stanislaus County General Plan; (b) finds that the proposed Planned Development zoning is consistent with the Agriculture General Plan designation; (c) the alternative to the Agricultural Buffer Standards applied to this project provides equal or greater protection than the existing buffer standards; (d) that the project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements; amended Development Standard No. 16.b. to read as follows: "Up to two (2) wall signs, one not exceeding 32 square feet in size on the Cold Storage building, and one "CALOY" identification sign on the Bottling building facing south and not exceeding 45 square feet in size, in the expansion area, the signs shall be limited to one (1) sign per building"; approved Rezone Application No. PLN2023-0065 – Caloy Company, LP, subject to the development standards as amended and development schedule in Attachment 7 of the agenda item; and, introduced, waived the reading, and adopted Ordinance C.S. 1383 for the approved Rezone Application No. PLN2023-0065 – Caloy Company, LP – Planning ORD-58-Q-2 2024-0654
