Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

November 12, 2024

Invocation was given by Pastor Latricia Beasley-Day with Faith in the Valley.

Jody Hayes, CEO's Office, Lorena Balderas and Manuela M. Leon from CSA, Jason Dean McCormick from Public Works, and Pedro Beltran from the Sheriff's Department received their 25-year Employee Service Awards. Elizabeth King from the CEO's Office received her 30-year Employee Service Award; and, Isabel Campos from CSA received her 35-year Employee Service Award.

Chairman Grewal acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Ron McMurtry voiced concerns regarding his homeowner's association emergency assessment which will increase his homeowner's insurance premium. He asked the Board for assistance directing him to someone who could look into the legality of this matter.

Steven Morrow spoke regarding the election and shared that today is the last day for properly postmarked ballots to arrive and be counted. He shared he continues to serve on the Keyes Municipal Advisory Council and the StanRTA Board.

Nicole Krause, homecare provider for In-Home Supportive Services and member of the United Domestic Workers (UDW) Union, shared she is here to represent the 7,000 IHSS providers in the County and looks forward to upcoming conversation on 11/18/2024. She thanked the Board for all they do for the community.

Nancy Robinson, President of the Modesto Garden Club, shared what projects the Garden Club is involved in and spoke regarding the annual Elegant Holiday Table Viewing on Wednesday, 12/11/2024 from 1:00 p.m. – 7:00 p.m. at the Del Rio Country Club and the Holiday Home Tour on Saturday, 12/14/2024 from 10:00 a.m. – 3:00 p.m. Visit www.modestogardenclub.org for more information and ticket prices.

John X. Mataka shared concerns regarding the water issues at the Westley Migrant Camp and Grayson Charter School and asked what obligation the Housing Authority has towards protecting its tenants. He requested information about who to contact regarding this contamination issue.

Laura Plascencia spoke regarding the contract ending with Covanta and noted she looks forward to learning what the clean-up planning process and future waste management will look like in the County. She voiced concerns regarding the Farmworker Advisory Committee including the time of the meetings, accessibility, and possible retaliation on committee members. Milt Trieweiler spoke regarding the need to preserve agriculture land. He shared we have the responsibility to plan for our children and our descendants.

Dr. Ana Andrade, resident of Patterson, echoed John Mataka's comments and shared concerns regarding the water situation at Grayson Elementary School. She asked the Board to invest infrastructure dollars into schools.

Bianca Lopez, Vice-President of the Latino Community Roundtable, spoke on behalf of the farm working communities and shared concerns regarding the Farmworker Advisory Committee. She requested effective outreach, meaningful and insightful participation, bi-lingual townhall meetings at accessible locations, and a safe and welcoming environment.

Debbie Martinez shared she has been serving the disadvantaged community for 40 years and is a newly elected school board member. She thanked Stanislaus County and parents for equality in schools and the Board Members for all they have done for her.

Veronica Torres voiced concerns regarding hate crimes happening in the Parklawn neighborhood and a hate crime painting that has been on a fence for the past 6 months on Nelson Way.

Sebastian Cervantes shared concerns regarding the time of the Board meeting when addressing items regarding farmworkers and asked the Board to consider the time of these meetings going forward.

He plans to meet with Jim Kruse with the Housing Authority to discuss this product as well as the water situation in Westley.

Supervisor Chiesa shared he will attend the San Joaquin Valley Air Pollution Control District's Board Retreat this week and the annual California State Association of Counties (CSAC) conference next week.

CEO Hayes thanked the Elections staff for all their hard work. He noted you can visit the stanvote.com website for election results as they are updated. He reported that the Governor called for a special session of the Legislature.
