Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

December 3, 2024

Invocation was given by Pastor Lance Lowell with Neighborhood Church.

The Stanislaus County Office of Education 2024 Red Ribbon Week Best Decorated-Most Spirited School Contest Awards were presented to: Mesa Verde Elementary School, Northmead Elementary School, and Walnut Grove Elementary School; Creekside Middle School, Somerset Middle School, and Dutcher Middle School; and, Elliott Alternative Education High School, Denair High School, and Roselawn High School.

Miguel Donoso voiced concerns regarding flyers being distributed in the Parklawn area and in Ceres with violent hate messages. He shared he'd like the Board and Sheriff's Department to do something regarding this issue.

John X. Mataka, Grayson Neighborhood Council, also spoke regarding the violent hate messages in the Parklawn area and in Ceres and shared it's been going on for several months. He voiced concerns about the County's handling of these cases and requested that the Sheriff hold a meeting in the Parklawn neighborhood regarding this issue. He shared that he believes the Boards' behavior has changed towards Supervisor C. Condit and is concerned with how it may affect the services the Westside receives.

Dan Avila voiced concerns regarding delays and communication problems with the Planning and Community Development Department concerning a Use Permit from 2018.

Elwyn Heinen, the engineer assisting Dan Avila, shared concerns regarding the lack of response when asking for help with the approval of Use Permit from 2018.

Alyssa Leva shared that she witnessed a hate crime and voiced concerns regarding threats and hate speech happening in Stanislaus County. She asked the County to hold the Sheriff's Office accountable.

Speaker 1 voiced concerns regarding threatening and hateful graffiti, stickers, and signs in the Parklawn and Ceres area targeting Latino neighborhoods. She shared that there are similar hate speech and threats directed at Black communities. She voiced concerns about the County's handling of these cases. She read a list of requests for the County including, increased transparency, a public statement condemning these acts of hate, for the Sheriff to attend this Thursday's community meeting in Parklawn, and the implementation of a Civilian Review Board for the Sheriff's Department. She submitted a verbal public records request, asking the County to provide a written response by the end of this week, including the requested transparency and confirmation of the next steps.

Nick Jensen, attorney with California Rural Legal Assistance, shared they have worked with the Parklawn community the past 20 years. He voiced concerns that the sign with the hate message keeps being put back up after being taken down. He spoke regarding the importance of collaboration, communication and

building trust with law enforcement. He shared the community would like law enforcement to regularly attend the monthly meetings in the Parklawn area.

Manuela voiced concerns regarding racist stickers, flyers, and hate speech in the Central Valley. She shared concerns regarding racism towards Mexicans, immigrants, refugees, undocumented individuals, and people of other religious backgrounds. She spoke regarding the City of Turlock efforts to combat racism, and she asked the Sheriff's Office to do something about the racism in the County.

Supervisor Chiesa reported he attended several meetings over the past couple weeks, one of them being the California State Association of Counties (CSAC) conference where he was appointed to the California Statewide Communities Development Authority (CSCDA). He also shared Public Works Director, David Leamon, was sworn in as President of the County Engineers Association of California (CEAC).

Supervisor B. Condit reported that he attended the CSAC conference and that he enjoyed attending and collaborating with fellow County Supervisors.

Chairman Grewal spoke regarding the CSAC conference and shared he was appointed Chair of the Government Finance and Administration (GFA) Policy Committee. He also shared he is on the Homeland Security Committee, as a representative from CSAC, and the National Association of Counties (NACO).

Supervisor C. Condit reported last night he attended the South Modesto Business United Annual Christmas Tree Lighting Ceremony. He recognized Lane Avila, in Code Enforcement, for his quick response and cleanup of an illegal dumping on a canal bank in South Modesto in proximity to the Christmas Tree Lighting Ceremony. He spoke regarding the timeline of community complaints concerning the sign in the Parklawn area and asked about the procedure for these types of reporting. He requested the County release an official public statement denouncing hateful remarks and violence against all forms of people, and work with the Sheriff's department to determine what can be improved in regards to reporting and working in a collaborative fashion.

Supervisor Chiesa also spoke regarding the sign in the Parklawn neighborhood. He shared concerns regarding the pace and procedure of how situations like this are handled. He encouraged the public to call the Sheriff's non-emergency line when they see issues like this at 209-552-2468, or if you don't feel secure doing this, to call the Board Office.

Supervisor B. Condit noted if people are scared to call the Sheriff's Department, they can also call Stanislaus Area Crime Stoppers at 1-866-602-7463 and remain anonymous.

CEO Hayes acknowledged there was public comment made during a recent Board meeting regarding hate graffiti in the Parklawn neighborhood. He will look into this and report back why it was not addressed in a timely manner. He shared staff will prepare a message on behalf of the County denouncing hate speech.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
