Invocation was given by Pastor Dallas Jackson with Renew Church.

Supervisor Withrow presented a certificate to Donald Storer, with Storer Transportation, recipient of the National 2024 School Bus Contractor of the Year Award.

Joni Griep shared concerns regarding the newly released Congressional Committee Report on COVID-19. She acknowledged the Board for listening to frontline staff and passing a resolution that ended the public health emergency one year earlier than the State.

Jennifer Ann (Rally) Aoyama, IHSS provider for her twin boys, spoke regarding IHSS providers' roles and the ability to care for her children in their home. She voiced concerns regarding IHSS provider wages and asked the Board to help be the voice to help IHSS providers earn a living wage.

Chantal Turner, IHSS provider, shared concerns regarding IHSS providers' wages. She encouraged the Board to give a wage increase.

Mary Anne Reynolds voiced concerns regarding the slow response to the hate stickers in the City and County and asked the Board to explore the slow response time by the Police and Sheriff's Office.

Brandon Kirkbride, Stanislaus Sworn Deputies Association, shared concerns regarding recruitment and retention problems at the Sheriff's Office and statewide. He asked the Board to work with the Association to help close the gap and stay competitive.

Matthew Orr, Stanislaus Sworn Deputies Association, voiced concerns regarding base pay and asked the Board for their cooperation in increasing the base pay.

Sheriff Dirkse spoke regarding the hateful messages in the Parklawn and Ceres areas that were brought up during public comments at last week's Board meeting. He reported that this was a long-term and ongoing issue, and the department faced a challenge because they had no police reports with any kind of specificity. He shared the department will release a public service announcement today to that affect. He encouraged the public to either make a police report, call the non-emergency number, or call Stanislaus Area Crime Stoppers. He shared that once a community member informed the department, a person was identified and later arrested.
