Moment of silence was held for CSA employee Salvador Diaz.

Invocation was given by Pastor Lonnie Skiles, with Big Valley Grace.

Patricia A. Tout, Arild Baerheim, and Jaklin Benyamin from CSA received their 25-year Employee Service Award. Lori D. Mendonza and Pamela J. Kinser from CSA received their 30-year Employee Service Award.

Chairman B. Condit acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Nancy Robinson, President of the Modesto Garden Club, invited everyone to attend an Arbor Day event on Friday, 03/07/2025 at 10:00 a.m. at Enslen Park, where they will plant a native Valley Oak tree. She also spoke regarding their Annual Spring Garden Tour on Saturday, 04/12/2025.

Rhonda Allen spoke regarding the importance of planting native plants and trees and commended the Modesto Garden Club for planting a tree with substance. She also encouraged the County to require developers to protect the river areas in the County and plant more trees.

Bryan Evitt voiced concerns regarding the health and safety at the County jail and the Sheriff's budget.

Randon Kirkbride, Stanislaus Sworn Deputies Association, spoke regarding recruitment and retention problems at the Sheriff's Office and shared he would like to see recruitment increase.

Sandy Moreno, Regional Manager with United Domestic Workers (UDW), shared concerns regarding the wages and benefits of homecare providers and asked the Board to come to a resolution.

Astrid Zuniga, IHSS provider, voiced concerns regarding the challenges of being a provider and asked the Board for fair wages and benefits.

Nicole Krause, IHSS provider, shared concerns regarding the challenges of being a caregiver. She asked the Board to invest in caregivers and requested a wage increase.

Ronald F. Owens, Jr. voiced concerns regarding the California Department of Public Health. He also shared concerns regarding COVID-19 vaccine-related deaths and injuries. He urged the Board to stop promoting, administering and distributing the COVID-19 vaccine.

Matthew Orr, Stanislaus Sworn Deputies Association, shared concerns regarding wages and asked the Board for reasonable compensation.

Brenda Gonzalez spoke on behalf of her mom, Gloria Gonzalez, and asked the Board for help regarding her mother's mobile home park and issues with the landlord.

Chantel Turner, IHSS provider, voiced concerns regarding her health benefits and asked the Board for a wage increase.

CEO Hayes reported that yesterday the White House announced a pause on all federal grants and loan programs, including appropriated community project funds that have not yet been dispersed. He shared that this memo came from the Office of Management and Budget, which resulted in the cancellation of a meeting the County had scheduled with the Environmental Protection Agency (EPA), pending further guidance regarding the Crows Landing Water Wells Project. He noted that this project had received a \$3.4 million allocation from the FY 2023 Omnibus package. He shared the County is beginning to see the potential effects of this memo at the federal level and is working closely with State and federal legislative advocates and California State Association of Counties (CSAC) will monitor all updates and any potential local impacts. He also shared that clarifications are emerging, indicating the intent of the memo is to not impact direct services provided to individuals that are federally funded.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
