Invocation was given by Pastor Andrew Sampson with Modesto Church of Brethren.

Terry Johnson, Economic Development, Labor and Industry Committee Chair of the NAACP Modesto/Stanslaus Unit 1048 received a resolution proclaiming February 2025 as Black History Month in Stanislaus County.

Chairman B. Condit acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Randon Kirkbride, Stanislaus Sworn Deputies Association, voiced concerns regarding the vacancy rate and retention problems at the Sheriff's Office and asked the Board for their help.

Mike Roy Baptista, Older Child of God, shared concerns regarding the receipt of unemployment benefits and the Medicare system.

John Bauman, Stanislaus Sworn Deputies Association, thanked the Stanislaus Regional 911 (SR 911) dispatchers for their hard work and shared his family's personal experience with calling 911. He voiced concerns regarding transfer times, issues with SR 911 JPA, and inadequate pay received by dispatchers. He also shared concerns regarding the differences between Oracle and Central Square.

Teresa Pratt, SR 911 Dispatcher, voiced concerns regarding the Sheriff's presentation from last week's Board meeting and Ceres Dispatch staffing issues.

Matthew Orr, Stanislaus Sworn Deputies Association, shared concerns regarding the continued retention issues at the Sheriff's Department.
