Pledge of Allegiance to the Flag

A moment of silence was held for Community Services Agency Employee, Luis Maldonado.

Invocation was given by Pastor Dallas Jackson, with Renew Church.

Supervisor B. Condit acknowledged the passing of Richard Edgecomb, the founding member of the Veterans Advisory Commission, and Bob Phelan, a former Board of Supervisors Field Representative.

Michael Owens shared concerns regarding Senator Marie Alvarado-Gil, from California's 4th State Senate District, removing veterans from a press conference last year. He asked the Board to meet with her regarding the matter.

Hallie Van Deventer, from a local nonprofit based in Modesto, shared they provide homeless services in Patterson and Riverbank, as well as migrant education at MJC and throughout the County. She shared a handout with the Board Members and spoke regarding the Sierra House, a men's transitional housing program in Riverbank. She also shared concerns regarding the closure of Naomi's House, a women and children's shelter in Patterson, which will close on 06/30/2025, due to lack of funding. She asked the Board what will happen to the women and children, especially the boys currently in the shelter, and noted that the Gospel Mission's women and children's shelter is at capacity.

Gregory Woods shared that he has been a constituent of the County for 25 years and after speaking with Supervisor Grewal's Field Representative yesterday, he decided to attend today's meeting. He voiced concerns regarding the previous public comment and spoke regarding three denied grants. He asked the Board whether there is a single department responsible for applying for federal funding for homeless housing and whether anyone has proposed creating a department solely dedicated to securing funding for the County.

Ramon Rodriguez shared concerns regarding stocks, economic uncertainties, and the Central Valley's agriculture industry. He voiced concerns regarding critical and essential services being cut by the government. He requested we return to free trade, job growth, and immigration reform to support farmworkers and stabilize the economy before a full recession takes hold.

**5.B.1** Authorized the DA to retroactively accept the award from the California Governor's Office of Emergency Services Victim/Witness Assistance Program in the amount of \$927,926 for FY 2025 and Budget Year 2026; authorized the DA, or designee, to sign and execute related agreements, contracts, amendments or other documentation, consistent with the County Purchasing Policy and within budget authority, required for the related Victim

**5.C.4** Approved the annexation of the Top Shelf Mega Storage project into the Golden State Lighting District; finds that the territory, APN: 045-052-031, is owned by the project proponent and its ownership represents 100% of the total assessed valuation of said territory; finds that the area included in the Legal Description of Top Shelf Mega Storage is located in the unincorporated territory of Stanislaus County and that it is not within the boundary of any Lighting District; finds that Stanislaus County Code, section 20.56.210 (Street Lights), requires the installation of the street lights to County standards in areas designated as residential, commercial, and industrial on the land use element of the General Plan; finds that the property owner was required to install street lights per Condition of Approval and Rezone Application No. PLN2021-0112 – Top Shelf Mega Storage; finds that pursuant to Streets and Highways Code, section 19056, territory owned by a property owner that comes under the terms of a county ordinance requiring the installation of a street lighting system (i.e. Stanislaus County Code, section 20.56.210 Street Lights) shall be exempt from Street and Highway Code requirements for petition, notice, hearing, and election requirements; finds that the annexation will not produce a change in assessment methodology or assessment rates for the Golden State Lighting District and that the parcel in the new territory shall be subject to that pre-existing methodology and rates; declared that all services being provided by Golden State Lighting District will be extended fully to the territory included in the said property annexation and that said services shall commence with the start of the 2025-2026 FY; ordered APN: 045-052-031, and its subsequent subdivided parcel numbers, to be added to the 2025-2026 FY annual assessments; directed the Department of Public Works to forward a certified copy of the resolution ordering the annexation, and all other required documents, along with the processing fee to the State Board of Equalization; directed the Clerk to send a certified copy of the resolution ordering the annexation to the following offices: the Department of Public Works, Assessor, Elections, Auditor-Controller, and the Clerk-Recorder; and, authorized the Director of Public Works to take any appropriate action necessary to carry out the purpose and intent of these recommendations – PW 2025-0116

**5.C.5** Approved Amendment No. 7 to the Professional Design Services Agreement for all-inclusive bridge engineering services with Consor North America, Inc., in the amount of \$114,000, for a total not-to-exceed amount of \$828,876, for the Cooperstown Road over Gallup Creek Bridge Replacement Project; directed the Auditor-Controller to increase appropriations and estimated revenues by \$114,000 in the Public Works Road and Bridge budget unit; authorized the Director of Public Works to execute Amendment No. 7 with Consor North America, Inc., in the amount of \$114,000, and to sign necessary documents;

and, authorized the Director of Public Works to take any appropriate action necessary to carry out the purpose and intent of these recommendations – PW 2025-0117

**5.D.2** Rescinded a portion of Williamson Act Contract Nos. 1971-444 and 1972-470, and all of Williamson Act Contract No. 2006-005, located at 5107 Crabtree Road, between Warnerville and Barnett Road, in the Waterford Area, APN's: 011-006-019, 011-006-020, 011-006-025, and 011-006-038; pursuant to Government Code Section 51257, determine that the following seven findings can be made based on the written evidence submitted by the applicant: (a) the new contract, or contracts, would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contract, or contracts, but for not less than ten years, except as authorized under the County's implementation of AB 1265; (b) there is no net decrease in the amount of the acreage restricted, in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; (c) at least 90 percent of the land under the former contract, or contracts, remains under the new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved a new contract(s), pursuant to Lot Line Adjustment No. PLN2024-0040, covering APNs: 011-006-019, 011-006-020, 011-006-025, and 011-006-038; and, authorized the Director of Planning and Community Development to execute a new contract(s), pursuant to Lot Line Adjustment Application No. PLN2024-0040 – Brown – Mangante, covering APNs: 011-006-019, 011-006-020, 011-006-025, and 011-006-038 – Planning 2025-0119

Supervisor Chiesa shared that he, along with Supervisor B. Condit, attended the Commission on Aging meeting yesterday, where they recognized Margie Palomino, Director of Aging and Veterans Services, for 39 years of service and upcoming retirement. He also shared that last week, he attended the 20th Anniversary of the Alexander Cohen Hospice House and ribbon cutting ceremony for the Foster Family Suite, a pediatric room with additional space for parents.

CEO Hayes reported that, at the federal level, with the current continuing resolution expiring on Friday, the House and Senate Appropriations Committees are still working to find a path forward for FY 25 appropriations bills. He noted it is becoming increasingly likely that Congress will need to pass another continuing resolution to avoid a government shutdown, as bipartisan funding negotiations remain stalled.

He acknowledged Deputy Executive Officer Erica Inacio was recognized at the Capitol yesterday as the 22nd Assembly District's 2025 Woman of the Year. He also announced in accordance with Government Code Section 54953(c)(3), the appointment of Heather Duvall to serve as the Director of Health Services Agency, with a starting salary of \$97.87 per hour plus Department Head benefits.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
