5.B.2 Authorized the Public Defender to implement the Community Corrections Partnership funded programs as approved in the FY 2025 Community Corrections Partnership Plan for 2011 Public Safety Realignment; and, amended the Salary and Position Allocation Resolution to reflect the recommended changes outlined in the Staffing Impacts section of the agenda item, effective the first full pay period after Board approval – Public Defender

5.B.3 Approved the use of Community Development Funds for t-shirts, snacks, and drinks for the Jackson 3 Foundation Baseball Camp; and, approved \$5,000 of Community Development Funds to sponsor the Jackson 3 Foundation Baseball Camp starting on 05/29/2025 – CEO

5.C.1 Approved the plans and specifications for the East Las Palmas Avenue over San Joaquin River Bridge Maintenance Project, Federal Aid Project No. BRLS-5938(200); awarded a construction contract to Golden State Bridge, Inc., for the East Las Palmas Avenue over San Joaquin River Bridge Maintenance Project; authorized the Director of Public Works to execute a contract with Golden State Bridge, Inc., in the amount of \$2,461,899 and to sign necessary documents; authorized the Director of Public Works to execute change orders, not-to-exceed 10%, in accordance with the Public Contract Code, Sections 20137 and 20142; authorized the Director of Public Works to accept the completed improvements and perform all necessary closeout activities upon project completion; directed the Auditor-

Controller to increase estimated revenue and appropriations by \$3,077,374 in the Public Works Las Palmas Over San Joaquin Bridge project Legal Budget Unit per the budget journal, attached to the agenda item; and, authorized the Director of Public Works to take any appropriate action necessary to carry out the purpose and intent of these recommendations – PW

5.C.2 Proclaimed 05/18/2025 through 05/24/2025, as Stanislaus County Public Works Week, in conjunction with National Public Works Week – PW

5.C.3 Adopted the resolution summarily vacating a portion of public utility easement at Del Mar Court (previously abandoned to the public right-of-way); finds, based on the reasons stated in the agenda item, that the portion of public utility easement, is not required for utility purposes; and, directed the Department of Public Works to record the resolution with the County Clerk-Recorder – PW

5.C.4 Retroactively approved Contract Change Order No. 2 to the Construction Agreement with United Pavement Maintenance, Inc., in the amount of \$149,203, for the Keyes Road Asphalt Rubber, Pelletized Test Sections, and Fiber Reinforced Overlay Project; approved an increase to the construction budget for the Keyes Road Asphalt Rubber, Pelletized Test Sections, and Fiber Reinforced Overlay Project by \$149,203 from \$2,243,714 to \$2,392,917; authorized the Director of Public Works to execute Contract Change Order No. 2 with United Pavement Maintenance, Inc., in the amount of \$149,203, and to sign necessary documents; approved the use of \$149,203 in Measure L Local Streets and Roads funds for the Keyes Road Asphalt Rubber, Pelletized Test Sections, and Fiber Reinforced Overlay Project; directed the Auditor-Controller to increase appropriations by \$298,406 and estimated revenue by \$149,203 in the Public Works Road and Bridge budget unit; and, authorized the Director of Public Works to take any appropriate action necessary to carry out the purpose and intent of these recommendations – PW

Condit/Chiesa unan. **7.3** Pursuant to California Government Code Section 8630, ratified the proclamation of a local emergency in Stanislaus County due to the migration of the beet leafhopper in Stanislaus County; and, authorized the Director of Emergency Services to take the necessary actions in accordance with Stanislaus County Code Section 2.52.110 to respond to the emergency – OES/Fire Warden

CEO Hayes reported that the budget is the key topic at both the federal and state level. He noted the County is awaiting the Governor's May Revise Budget, which may include significant changes. He also noted the Board sent a letter of support to the State Senate and Assembly Budget Subcommittees advocating for funding for county-administered housing and homelessness programs.
