Invocation was given by Pastor Lance Lowell with Neighborhood Church.

Commendations were presented to Arlene Halford (District 1); Greg Bava (District 2); Jennifer Mullen (District 3); Denise Nordell (District 4); Loveada Fresquez (District 5) as the 2025 Stanislaus County Outstanding Senior Citizens of the Year in celebration of Older Americans Month.

The 2025 Stanislaus County Recycling Poster Contest winners received their awards.

Rod Olsen, with Crimson West Consulting, representing Recology, shared that Recology has, over the past several years, established and awarded scholarships to graduating high school students pursuing a college education in agriculture.

Tim Hester, General Manager of Recology Blossom Valley Organics North, presented the 2025 Recology Ag Scholarship Awards to recipients: Alyssa Guerrero, Lexiah Lopez, Shawn Seril, Tania Camacho; and, Natalie Ibarra.

Malinalli spoke in support of farmworkers and a civilian police oversight committee in Patterson. He also voiced concerns regarding law enforcement.

Mr. Gonzalez spoke in support of an independent citizen review board to ensure accountability and address misconduct by law enforcement. He also shared concerns regarding law enforcement.

Milt Trieweiler shared concerns regarding building on agricultural land and urged the Board to preserve farmland for future generations.

Bryan Evitt voiced concerns regarding the lack of accountability and responsibility within the Sheriff's Department. He spoke in support of a police oversight board.

John X. Mataka, representing Valley Improvement Projects and the Grayson Neighborhood Council, asked the Board to establish a citizen oversight review board with an independent auditor, similar to the model used by the City of Modesto, to improve accountability and community trust in law enforcement.

Bianca Lopez, co-founder of Valley Improvement Projects, asked the Board to place an item on a future agenda regarding the creation of a civilian review board for the Sheriff's Department. She voiced concerns regarding transparency, accountability, and lack of community trust in the department.

Supervisor C. Condit reported that a community cleanup took place in the Grayson Community, where eight garbage bins were filled with the help of volunteers, including support from the West Stanislaus Fire Department and their Explorer program. He also provided an update on the June 30<sup>th</sup> water termination deadline in Diablo Grande and shared details of the ongoing collaborative efforts to develop both short- and long-term solutions.

Supervisor Chiesa shared that he, along with Supervisor Grewal, attended the Latino Chamber event where Doug Ridenour and Jenny Kenoyer received the Legacy Award. He also shared he visited the newly opened Columbia Park Pool in Turlock and celebrated Francisco Velasquez, a dedicated worker who recently became a U.S. Citizen after a seven-year journey.

Chairman B. Condit shared a public safety reminder that fire season has begun and urged residents to create defensible space around their homes, clean their gutters, and remain vigilant, as embers can travel over a mile and spark new fires.

CEO Hayes provided an update regarding the Governor's May Revise Budget. He noted that it proposes nearly \$12 billion in actions to address the State's projected deficit, with rising Medi-Cal costs and slower economic growth as key factors, with long-term projections indicating further fiscal imbalances. He shared that local impacts may include cuts to health and social service programs, the loss of homeless shelter funding, and reduced support for child welfare and probation services, all of which could be worsened by potential federal budget reductions.
