June 10, 2025

Invocation was given by Kristine Kauffman, Rescue Director, with CrossPoint Community Church.

Chelsie Webster, CEO, gave an update regarding the Modesto Children's Museum.

Landon Whitney, with Senator Marie Alvarado-Gil's Office, shared the positive contributions of Cambridge Academies, a non-profit founded in 2004, to the community and presented a resolution, on behalf of the Senator, honoring Cambridge Academies as the 2025 Riverbank Nonprofit of the Year.

Tera Chumley, Director of Parks and Recreation, invited everyone to the 29th Annual Fireworks Celebration on Saturday, 06/28/2025 at approximately 9:30 p.m. at the Woodward Reservoir. She shared advance tickets can be purchased through their website and food vendors will be on site. She also shared the RecVan has begun operating and will run through August, from 12 p.m. to 5 p.m. at rotating parks, and the schedule is available on their website at <u>www.stancountyparks.com</u>.

Dave Leamon, Director of Public Works, shared updates on approved funding for the 7th Street Bridge. He shared that if all goes as planned, they can get construction started by next spring.

Gavin Bruce, a lifelong resident of Modesto, shared his work with nonprofits in the community over the last ten years. He shared the need for educational programs and zero waste programs. He also shared that there are vacancies on the local taskforce on solid waste that need to be filled so regular meetings can be held.

Steven Morrow shared concerns regarding the hazards of railroad crossings. He shared that a tragic incident occurred yesterday and emphasized the importance of safety around railroads.

Roberta shared concerns about the lack of accountability for the Sheriff's Office and emphasized the need for a community police review board, and reallocation of funding for the Sheriff's Office and police.

Bianca Lopez, with Valley Improvement Projects, advocated for a civilian review board for the Sheriff's Office to help create a trustworthy network with the community. She shared this will create a system that allows proper communication, transparency and accountability.

Anthony spoke in support of a civilian review board for the Sheriff's Department because it will rebuild the community's trust. He shared the civilian review board for the City of Modesto has been successful and invited the Board to the next meeting on 06/18/2025 at 5:30 p.m.

Carla shared concerns regarding the Sheriff's Department and the need for a civilian review board as an accountability measure.

John Carlo, with the Central Valley Black Indigenous People of Color Coalition (CVBIPOC), shared concerns regarding the Stanislaus County Sheriff's Department and the need for a police community review board for improved transparency, accountability and community trust. He also shared concerns about ICE in Stanislaus County.

Speaker No. 11 voiced concerns regarding the City of Patterson and the Sheriff's Office towing her car and trailer. She also shared concerns about the District Attorney's Office.

Supervisor C. Condit shared concerns regarding a letter issued by Senator Marie Alvarado-Gil about the Western Hills Water District's ongoing water crisis. He provided an update on the situation, noting that he and Supervisor Withrow have held several joint meetings with all the local irrigation districts in the County to brainstorm short and long-term solutions. He also shared that he had multiple meetings with Governor Newsom's office, and with private entities, and that all options are currently being considered. He thanked Supervisor Withrow for his consistent support, as well as Assemblymember Alanis and his staff. Additionally, he shared his support for the Pride community, noting he was the first supervisor to proudly present the Pride Proclamation while serving as Chair of the Board in 2023.

Supervisor Chiesa thanked Supervisors C. Condit and Withrow for their continued engagement with the Western Hills Water District and acknowledged that it's a difficult predicament.

CEO Hayes noted that the State budget is being released this week and that he will provide an update at a later time. He also shared that Senator Alex Padilla formally submitted Stanislaus County's \$1.8 billion Del Puerto Canyon Public Safety Communications Infrastructure Installation Project as a funding request to the Commerce, Justice, and Science Subcommittee for consideration and inclusion in the FY 2026 budget.

Chairman B. Condit announced that the State of the County Address will take place on Tuesday, 07/01/2025 at 9:00 a.m. in the Board Chambers.
