Invocation was given by Board of Supervisor Terry Withrow.

Baljit Atwal, Director of Child Support Services was presented with a commendation upon her retirement from Stanislaus County.

Baljit Atwal, Director of Child Support Services, gave a presentation on Child Support Awareness Month.

Tera Chumley, Director of Parks and Recreation, gave a presentation on Parks and Recreation Month.

Mark Ferreira, Chief Probation Officer spoke regarding 07/20/2025–07/26/2025 as Probation Services Week in Stanislaus County.

Lilia with the Grayson Youth Advocacy Group voiced concerns regarding improvements needed at the Grayson Community Park. She also thanked the Parks and Recreation Department for the enhancements made so far.

Luchie Sanchez with the Grayson Youth Advocacy Group spoke in support of retrofitting Grayson Community Park and highlighted the collaborative efforts underway in the community. He also thanked Parks Director Tera Chumley for the recent improvements made at the park.

Valerie Brambila with the Grayson Youth Advocacy Group spoke in support of improvements to the Grayson Community Park and shared that these enhancements will promote a healthy lifestyle for the community.

Jose Manuel with the Grayson Youth Advocacy Group spoke in support of improvements to the Grayson Community Park and shared concerns regarding the park receiving hand-me-downs from other parks. He shared he hopes the park gets renovated soon.

Sairah Waller with the Grayson Youth Advocacy Group spoke regarding the positive impacts an all-ages retrofitted park could have on the well-being of the Grayson Community.

Edgar with the Grayson Youth Advocacy Group spoke regarding the community outreach this group has done and spoke in support of improvements to the Grayson Community Park. He also shared he added workout stations to the wish list for this park.

Leonardo Garcia with the Grayson Youth Advocacy Group shared concerns regarding Grayson Community Park and spoke regarding the group's prioritized wish list for the park's improvements. He asked the Board for their support when they work on the Master Plan for this park.

A representative with the Grayson Youth Advocacy Group asked for support for improvements to Grayson Community Park. He also shared outreach, advocacy and fundraising efforts the group has participated in. He also thanked the Parks and Recreation Director for her help with improvements.

John Mataka with the Grayson Neighborhood Council voiced his support for the youth who spoke and commended the care they demonstrated for their community. He shared the group is actively fundraising and volunteering their time to help improve their local park.

Daniel Nickles, CEO and President of WLC and Willow Landing, shared concerns regarding the challenges of developing housing for veterans in the City of Patterson. He asked the Board for assistance in navigating Measure E and the restrictions it imposes on housing development.

Bryan Evitt shared support for the youth advocating improvements to their local park and voiced concerns regarding practices at local hospitals, advocating for better protection of patients and their families. Additionally, he shared concerns regarding the lack of care for incarcerated individuals, sharing his own personal experience.

Representative Joey Chavez from Senator Marie Alvarado-Gil's office provided a legislative update on SB229, shared information about mobile office hours, and noted that the Senator recently attended the Stanislaus County Fair and had a great time.

Laura Plasencia, a community organizer with the Valley Improvement Project, advocated on behalf of the Grayson Youth Advocacy Group. She asked the Board for consideration in prioritizing areas geographically isolated such as Grayson and encouraging collaboration to allocate more funding for rural communities.
