August 19, 2025

Convened at 5:32 p.m. for Special Session

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

1. Conferenced with Labor Negotiators: Pursuant to Government Code Section 54957.6. Agency Negotiators: Jody Hayes, Ryan Leupp, and Joanna Navarro. Labor Organizations: Service Employees International Union, Local 521; County Attorney's Association; Deputy Sheriff's Association; Stanislaus County Sheriff's Management Association. No reportable action was taken.

Reconvened at 6:35 p.m. for Regular Session

Invocation was given by Pastor Scott Elliott with Big Valley Grace Community Church.

Supervisor C. Condit presented a commendation in recognition of Damon Flores' achievements in youth boxing.

Chairman B. Condit acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Dr. Cameron Perez, a third-year family medicine resident at VCME, shared concerns regarding staff shortages and uncompetitive pay. He asked the Board to support this program to protect the healthcare of the community.

Carmen Villa shared concerns about limited telecommuting, increased workloads, and low wages. She shared the need for flexible work, adequate staffing, and fair compensation.

Aimee Johnson spoke regarding her mother, who is social worker, voiced concerns about wages and workloads and spoke in support of fair pay.

Steven DePoschalis spoke in opposition to the proposed Del Puerto Dam, and shared the Canyon should be preserved as a park.

Kent Mitchell, Political Chair of the Yokuts Group, spoke in opposition to the proposed Del Puerto Canyon Dam.

Nick Guzman spoke about staffing shortages at BHRS and shared concerns regarding overwhelming caseloads and staff burnout. He urged the Board to prioritize filling these positions so staff can provide high quality of care to the community.

Molly Rodriguez spoke on behalf of her coworker, Veronica Webster. She shared Veronica helped a distressed client, and her quick actions prevented a potential tragedy. She shared that employees face high-risk situations without protection but continue to serve with compassion.

Corie Crowson, an IHSS provider and UDW member, spoke on behalf of Astrid Zuniga in support of fair pay for IHSS workers.

Hortencia Flores, a Senior Community Health Worker and a SEIU 521 member, shared staff are overwhelmed by high caseloads and spoke in support of fair wages for the work they do to help the community.

Jody Smith, a Behavioral Health Specialist and SEIU 521 member, shared that staff are overwhelmed by understaffing and high caseloads and spoke in favor of a fair contract to prevent burnout so Stanislaus County can thrive.

Bryan Bolduc, a Behavioral Health Specialist in Stanislaus County and SEIU 521 member, shared staff are understaffed and spoke in support of a fair contract so employees can provide quality care to help build a healthier, safer community.

Hilary Moak spoke in opposition to the Del Puerto Canyon Dam. She shared the Del Puerto Canyon supports rich biodiversity of plants and wildlife, cultural sites, educational experiences, and provides open access to nature and recreation.

Maria Martinez, a social worker with IHSS, spoke regarding staff shortages, overwhelming caseloads and dangerous conditions of their home visits.

Bryan Evitt spoke in support of fair wages for home care workers.

Ronald F. Owens Jr. voiced concerns about COVID-19 vaccines.

Jan, a retired respiratory therapist, shared concerns about vaccines.

Arne, a Modesto resident and a teacher, spoke in opposition to COVID vaccines and expressed support for ending vote-by-mail in Stanislaus County to reduce fraud.

Kent voiced concerns regarding mail-in voting and vaccine safety.

Melinda Mason spoke about the New State of California movement.

David Avila spoke regarding preserving the valley and the We the People movement.

Rhonda Allen, a Modesto resident and a member of the California Native Plant Society, shared information about Del Puerto Canyon's rare plants and wildlife habitats. She spoke about the need to protect this biodiverse hotspot.

Christina Guevara, a Stanislaus County mental health clinician, shared concerns about chronic understaffing and heavy caseloads. She urged the Board to support fair wages.

Elias Funez, a Patterson resident, spoke in opposition of the proposed Del Puerto Dam and shared safety concerns about the rerouting of this road.

Hector shared the need to protect Del Puerto Canyon's natural wildlife, native plants, and insects. He also voiced concerns about earthquake and flooding risks.

Sevy Toscano spoke in opposition of the proposed Del Puerto reservoir.

Maria Gabriel, a Stanislaus County resident, voiced concerns about the impacts of the proposed dam on important Indigenous cultural sites in Del Puerto Canyon.

Gavin Bruce spoke in opposition of the Del Puerto Canyon project and also shared support for better pay and conditions for behavioral health workers.

Karyn Clark urged the Board to support fair pay and retention of employees.

Sherie Johnson, a SEIU member, spoke regarding the need for better wages for the impactful work social workers do every day.

Speaker #1 shared the need for Board meetings to be offered via Zoom to increase public participation, expressed safety concerns about the proposed dams in Del Puerto Canyon, and highlighted the importance of preserving the canyon's natural landscape, indigenous heritage, and cultural value.

Anne Marie spoke in support of COVID-19 vaccines and shared concerns regarding the effects of the COVID-19 pandemic.
