Invocation was given by Pastor Mike Douglass with The Serving Church Fellowship.

Linda Pinfold, Agricultural Commissioner/Sealer of Weights and Measures, provided an update on the Stanislaus County 2024 Agricultural Crop Report.

Doris Foster, Director of Workforce Development, received a resolution proclaiming September 2025 as Workforce Development Month in Stanislaus County.

Tera Chumley, Director of Parks and Recreation, announced that after 15 years, the Bonita Pool will reopen this Saturday, 09/13/2025. She shared everyone is invited to a ribbon cutting at 11:00 a.m., and the pool will be open for free swim from noon to 5:00 p.m. every weekend this month.

Rita, from Riverdale Tract Park, voiced concerns about the length of time it is taking for improvements to be made in her district. She also shared concerns regarding the difficulty in obtaining recycling bins from the garbage company and spoke about composting.

Bryan Evitt, from Wood Colony, spoke regarding the 2024 Agriculture Crop Report and shared concerns about dispensaries. He also commented on the 2025 Workforce Development presentation, suggesting that the Carpenters Union be brought back to Stanislaus County. In addition, he voiced concerns about housing development and suggested adding beautifications near the Vintage Fair Mall toward Salida.

Steven Morrow voiced concerns regarding the Civil Grand Jury report and suggested that the Board consider purchasing a Washington Metro Fare Card for transportation instead of renting a car during visits to Washington, D.C.

Condit unan. **6.1** Public hearing, to consider the Planning Commission’s recommendation of approval for Rezone Application No. PLN2025-0005 – West Stanislaus Irrigation District, a request to rezone three parcels, totaling 11,250± square feet, from Single-Family Residential (R-1) to Planned Development (P-D), to allow for development of a 3,583± square-foot office for the West Stanislaus Irrigation District, located at 116 E Street, between Kern Street and Highway 33, in the Community of Westley; adopted the Negative Declaration pursuant to CEQA Guidelines Section 15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Negative Declaration reflects Stanislaus County’s independent judgment and analysis; ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder pursuant to Public Resources Code Section 21152 and CEQA Guidelines Section 15075; finds that: (a) the project is consistent with the overall goals and policies of the County General Plan; (b) the proposed Planned Development zoning is consistent with the Low-Density Residential General Plan designation; (c) the project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements; approved Rezone Application No. PLN2025-0005 – West Stanislaus Irrigation District, subject to the attached Development Standards and Development Schedule; and, introduced, waived the

Supervisor C. Condit announced there will be a September 11th Memorial Ceremony at Whitmore Park, 2nd Street, Ceres, on Thursday, 09/11/2025, at 8:46 a.m. He also shared that the Bonita Pool in Crows Landing will reopen this Saturday, 09/13/2025.

CEO Hayes reported on the federal budget deadline and expects a temporary resolution, as well as the end-of-session state legislative activity with numerous trailer bills under review. He noted counties are engaged on issues including land use and procurement, and that the Chairman signed a letter on behalf of the Board regarding AB 690, a two-year bill reforming indigent defense contracting with no direct impact to Stanislaus County. He also announced the release of the Recommended 2026 Final Adopted Budget, available on the County's website at www.stancounty.com/budget, which will be presented to the Board on Tuesday, 09/30/2025.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
