Special and Regular Session Supervisor C. Condit Absent Pledge of Allegiance to the Flag Tuesday

September 16, 2025

Convened at 5:30 p.m. for Special Session

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.

1. Closed session: Conferenced with Legal Counsel – Existing Litigation: Pursuant to Government Code Section 54956.9 (d)(1). Two Cases: Dorothy Heimbach et. al. v. Stanislaus County et. al. United States District Court Eastern District of California Case No. 2:23-cv-01887-DJC-KJN; Santor et. al. v. County of Stanislaus et. al. United States District Court Eastern District of California Case No. 1:19-cv-01593- MCE-DB. No reportable action was taken.

Supervisor C. Condit arrived at 5:36 p.m.

Reconvened at 6:31 p.m. for Regular Session

Invocation was given by Mike Gunnarson with City Ministry Network.

Chairman B. Condit and Board members presented the 09/15/2025-10/15/2025 Hispanic Heritage Month proclamation to the following community members: The Tinajero Family, Owners of El Ranchito Restaurant in Riverbank (District 1); Superintendent Jose Aldaco, Waterford Unified School District (District 2); Jose Sabala, Vice President CRA Officer, Oak Valley Community Bank (District 3); Adolfo Martinez, CASA Cultural Modesto (District 4); and, Pedro Marquez, Owner of El Rematito on Crows Landing Road (District 5).

Carmen Villa, Social Worker and SEIU 521 member, voiced concerns regarding high caseloads, burnout, and staff turnover. She asked the Board to support a fair contract to help prevent staff burnout and retain experienced workers.

Brent Jarvis, client of Adult Drug Court Program, shared his personal success story and shared concerns regarding overloaded staff, asking the Board to take this into consideration.

Mannie, mental health worker, voiced concerns regarding working conditions and asked the Board for fair pay, lower caseloads, and adequate staffing.

Amanda Barnett, Behavioral Health Specialist, shared concerns regarding caseloads, low pay and, and unsafe working conditions. She asked the Board to support fair wages, reduced caseloads, and improved staffing.

Chantenique Anderson, Social Worker, voiced concerns regarding rising caseloads, staff turnover, and the impact on families. She asked the Board to support fair wages and adequate staffing.

Carlo Vasquez, Behavioral Health Case Manager, shared concerns regarding high caseloads, low pay, and staff retention. He asked the Board to support fair wages and manageable caseloads.

Jody Smith, Social Worker, shared concerns regarding high caseloads and their impact on providing quality services to families. She asked the Board to support fair pay, reasonable caseloads, and adequate support to ensure child safety and family stability.

Rosalva Moreno, Behavioral Health Worker, voiced concerns regarding high caseloads, staff shortages, and the impact on both workers and client care. She asked the Board to support fair wages and adequate staffing.

Hortencia Flores, Behavioral Health Worker, shared concerns regarding caseloads and wages. She asked the Board to support fair wages and smaller caseloads.

Bianca Lopez, Homecare Provider, voiced concerns regarding workloads and the impact on both staff and families. She asked the Board to support fair wages to retain experienced staff.

CEO Hayes thanked the individuals who shared personal stories this evening and recognized the dedication and sacrifices of County employees. He acknowledged the challenges of the labor negotiations process, noting it is lengthy, often unpleasant, and constrained by state law. He shared wage increases of 11% over three years have been granted for the majority of County employees and emphasized the County remains committed to reaching fair agreements with all labor groups. He addressed SEIU's 30% three-year demand, explaining it was a starting point for negotiation and does not prevent continued discussion toward resolution. Lastly, he encouraged transparency, timely negotiations, and offered to meet individually with employees after the process concludes to provide further clarification.

Supervisor C. Condit reported that he had the privilege of attending a Mexican Independence Day celebration at El Ramatito in South Modesto and thanked the Marquez family and South Modesto Businesses United for organizing the event. He also noted the opening of the new Bonita Pool in Crows Landing, highlighting the ribbon-cutting ceremony and its positive impact on the community. He expressed appreciation to Tera Chumley, Director of Parks, Andy Johnson, General Services Agency Director, and others who contributed to the pool project.

Supervisor Grewal provided a statement condemning recent acts of political violence, emphasizing that such actions undermine free speech and open discourse and have no place in society. He reaffirmed the importance of civil disagreement, dialogue, and voting as core democratic values, while upholding the right of all individuals to express their views without fear. He offered thoughts and prayers for those affected and encouraged the community and nation to come together in unity and healing.

CEO Hayes thanked Supervisor C. Condit for his support in advancing the Bonita Pool project, including removing barriers and providing financing. He provided a legislative update, noting that the legislative

session unexpectedly extended into last Saturday, and that all bills are now either on the Governor's desk or held over, with staff reviewing them against the County's Legislative Platform. He also noted that, despite ongoing discussions about a potential federal shutdown, there are no anticipated impacts on services in Stanislaus County.
