Invocation was given by Pastor Scott Elliott with Big Valley Grace.

Ryan Kegley, Veteran's Services Officer, presented a resolution proclaiming November 2025 as Veterans and Military Families Month in Stanislaus County.

Commendations were presented to Ralph A. Lopez; Jim Champion; Don Gray; Doug Nutson; and, Richard Gomez as the 2025 Veterans of the Year.

Lorena Gutierrez, from CSA, received her 25-year Employee Service Award, Olga Ruezga from CSA, Hector Ayala, from ITC, and Desiree Tobar, from HSA, received their 30-year Employee Service Award; and, Ramona Brown, from HSA, received her 35-year Employee Service Award.

Sheriff Dirkse and Suzy Powell-Roos gave an update on the Stanislaus County Sheriff's Office Wellness Program.

Ron McMurtry spoke regarding proposed bus stops and shared he is putting a list together of dangerous intersections in Stanislaus County.

Marci Cole voiced concerns regarding traffic at Carpenter and West Main Roads and the proposed West Main Compost Facility project.

Milt Trieweiler, a lifetime Stanislaus County resident, shared concerns regarding building on agricultural land and urged the Board to preserve farmland for future generations.

Julianne Phillips, District Representative with Senator Alvarado-Gil's Office, provided an update on the district's activities.

Michael Masuda introduced himself to the Board and shared that he is running for Congress in the 5<sup>th</sup> Congressional District.

Sebastian Jones shared concerns regarding the need for automatic streetlights and road improvements in the Monterey Park Tract area. He voiced concerns regarding the time of daytime meetings and requested they begin at 10:00 a.m. He also shared that he has been working on the Martin Luther King project and asked the Board's help in placing two statues in Martin Luther King Park.

Dino Wilson voiced concerns regarding the Planning Commission and the noticing requirements related to the proposed compost facility near his home. He requested changes to the notification procedures for neighboring residents and asked the Board to discuss the number of complaints received regarding the proposed facility.

**5.B.1** Approved an amendment to the agreement with the City of Modesto and the CSA, acting as the designated Administrative Entity for the Stanislaus Community System of Care (CSOC), to increase the not-to-exceed amount by \$342,626 for a new contract maximum of \$2,117,703 funded by the Homeless Housing, Assistance, and Prevention (HHAP) Grant Program for the delivery of permanent housing and innovative housing solutions for the current term of 12/06/2023 through 04/30/2026; authorized the CSA Director, or designee, to sign the amendment to the agreement with the City of Modesto and CSA, acting as the designated Administrative Entity for the CSOC, to increase the not-to-exceed amount by \$342,626 for a new contract maximum of \$2,117,703 funded by the HHAP Grant Program for the delivery of permanent housing and innovative housing solutions for the current term of 12/06/2023 through 04/30/2026; and, authorized the CSA Director, or designee, to amend the agreement by up to 25% under the same terms and conditions, if approved by CSOC, within budget authority, and aligned with the Purchasing Policy, to meet the community's service needs – CSA C-6-T-5 2025-0576

**5.B.2** Authorized Department Heads to pay up to \$290 per employee, per year, for required safety shoes under the Safety Shoe Reimbursement program; and, authorized the County Risk Manager to review and approve future adjustments to the reimbursement rate every three years – CEO 2025-0577

**5.B.3** Approved a provider agreement with Telecare Corporation in the amount \$3,380,120 for the retroactive period of 08/01/2025 through 06/30/2026, to provide mental health services to transitional-age youth with serious mental illness; and, authorized the GSA/Purchasing Agent, or designee, to sign and execute the provider agreement with Telecare Corporation for the provision of services, in the amount of \$3,380,120, for the retroactive term of 08/01/2025 through 06/30/2026 – BHRS 2025-0578

**5.B.4** Approved an amendment to the Master Agreement with Champion Industrial Contractors, Inc. to increase the not-to-exceed amount for on-call mechanical and refrigeration services from \$500,000 to \$750,000; and, authorized the Purchasing Agent, or designee, to sign the Master Agreement and any subsequent amendments to the Master Agreement on behalf of the County, budget permitting and consistent with the County Purchasing Policy, throughout the term of the agreement – GSA 2025-0579

**5.B.5** Authorized the Sheriff to accept the Boating Safety and Enforcement Equipment grant of \$46,011 from the California Department of Parks and Recreation, Division of Boating and Waterways (DBW); authorized the Sheriff to sign any documents related to the grant and to administer the California Department of Parks and Recreation, Division of Boating and Waterways (DBW) Boating Safety and Enforcement Equipment Program grant for the project performance period; adopted a resolution to accept funding from the DBW for the

Boating Safety and Enforcement Equipment Grant, as required by the State; and, directed the Auditor-Controller to increase appropriations and estimated revenue by \$46,011 in the Sheriff's Operations budget – Sheriff 2025-0580

**5.B.6** Authorized the Sheriff to retire one (1) canine from the Sheriff's Office service and enter into a Canine Retirement Contract with the canine's current handler – Sheriff 2025-0581

**5.B.7** Approved the Stanislaus County Comprehensive Economic Development Strategy for the 2025-2030 period, as recommended by the Stanislaus County Economic Development Advisory Committee; and, authorized staff to submit the approved Stanislaus County Comprehensive Economic Development Strategy for the 2025-2030 period to the U.S. Economic Development Administration for federal review and acceptance – CEO 2025-0582

**5.B.8** Approved retroactively the use of \$2,500 of Community Development Funds for Soles for Kids 209, Inc. to provide 100 name-brand shoes to students at Empire Elementary School during their 10/10/2025, event – CEO 2025-0583

Supervisor Chiesa reported that there will be a community meeting regarding air quality next Wednesday, 11/12/2025, at the Community Collaborative, located at 529 California Avenue, Modesto. He shared the meeting will include Valley Improvement Projects (VIP), a representative from the Air District, Councilwoman Rosa Escutia-Braaton, and himself. He also noted for more information; individuals can call his office at (209) 525-6440.

Chairman B. Condit reported receiving a complaint from a constituent regarding an illegal marijuana grow that had been reported to Crimestoppers. He shared that the constituent was informed the enforcement team had been disbanded. He requested information regarding a grant received by the Sheriff's Office for illegal marijuana grow enforcement. He also requested a report from staff regarding the current status of funds in that budget and whether an illegal marijuana enforcement team is still in place.

CEO Hayes reported on the federal government shutdown and asked CSA Director Christine Huber to provide an update on the latest information regarding the funding of SNAP (CalFresh) benefits.

CSA Director Christine Huber reported that the USDA has submitted a plan to use \$4.3 billion in contingency funds to support SNAP (CalFresh) benefits, which would cover approximately 50% of the nation's benefits for November. She shared concerns regarding system programming challenges that may delay issuance of benefits. She also noted that the County is working with community partners to ensure residents have access to food and food-only gift cards.

Prior to adjourning into Closed Session an opportunity was given to the public to address matters listed under Closed Session.
