Invocation was given by Pastor Patrick Nagle with Redeemer Modesto.

The Stanislaus County Office of Education 2025 Red Ribbon Week Most Spirited School Contest Awards were presented to: Grayson Elementary School, Las Palmas Elementary School, and Caswell Dual Language Academy; Creekside Middle School, Dutcher Middle School, Emilie J. Ross Middle School, and Honorable Mention- Somerset Middle School; and, Hughson High School, Open Valley Independent Study, Del Puerto High School, and Roselawn High School.

Michelle Dunn, from Child Support Services, and Richard Hull from GSA, received their 25-year Employee Service Awards; and, Eva Parra, with Child Support Services, received her 30-year Employee Service Award.

Chairman B. Condit acknowledged receipt of written public comments. He noted that all public comments submitted via email were distributed to the members of the Board of Supervisors.

Ron McMurtry spoke regarding a list of intersections he had emailed to the Board that noted safety and transit concerns. He also voiced concerns regarding the Diablo Grande community, Crows Landing Business Park project, and immigration issues.

Ernie Garza, former General Manager of the Keyes Community Services District (KCSD), provided a handout to the Board and shared concerns regarding the district's governance and asked the Board to exercise its oversight authority and investigate KCSD's governance practices.

Milt Trieweler, a lifetime Stanislaus County resident, shared concerns regarding building on agricultural land and urged the Board to preserve farmland for future generations.

Bryan Evitt voiced concerns regarding the probate process contributing to homelessness, drug use, and crime. He urged the Board to take proactive steps to make the probate process easier and more supportive.

Richard Ruggiero, a resident of the Diablo Grande community, voiced concerns regarding financial practices by the Western Hills Water District. He urged the Board to investigate and shared that the matter should be referred to the Grand Jury.

Dan Vega spoke regarding the importance of local emergency preparedness in Stanislaus County and the City of Modesto. He shared concerns regarding the lack of long-term reserves for residents and urged the Board to support a pilot initiative aimed at strengthening food and water security.

Julianne Phillips, District Representative with Senator Alvarado-Gil's Office, provided an update on the district's activities.

former contract, or contracts, remains under the new contract, or contracts; (d) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Government Code Section 51222; (e) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract, or contracts; (f) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; (g) the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan; approved a new contract(s), pursuant to Lot Line Adjustment Application No. PLN2025-0041 – Yamamoto Family Farms, LP, covering APNs: 016-006-019, 016-006-020, and 016-006-023; and, authorized the Director of Planning and Community Development to execute a new contract(s), pursuant to Lot Line Adjustment Application No. PLN2025-0041 – Yamamoto Family Farms, LP – Planning

Withrow/C. Condit unan. **6.2** Conducted a public hearing to consider the Planning Commission's recommendation for approval of General Plan Amendment Application No. PLN2022-0045 – Sixth Cycle Housing Element Update, and finds the request exempt from the CEQA; finds the project is generally exempt from CEQA pursuant to CEQA Guidelines Section 15061 and Section 15282(h) and ordered the filing of a Notice of Exemption with the Stanislaus County Clerk-Recorder pursuant to CEQA Guidelines Section 15062; finds that there is no substantial evidence the project will have a significant effect on the environment and that the exemption reflects Stanislaus County's independent judgement and analysis; ordered the filing of a Notice of Exemption with the Stanislaus County Clerk Recorder's Office pursuant to CEQA Guidelines Section 15062; finds, based on the discussion in this report, and the whole of the record that: (a) the General Plan Amendment will maintain a logical land use pattern without detriment to existing and planned land uses; (b) the County and other affected governmental agencies will be able to maintain levels of service consistent with the ability of the governmental agencies to provide a reasonable level of service; and, approved General Plan Amendment Application No. PLN2022-0045 – Sixth Cycle Housing Element Update – Planning

C. Condit/Withrow unan. **6.1** Conducted a public hearing to consider the Planning Commission's recommendation for approval of General Plan Amendment, Rezone, and Ordinance Amendment Application No. PLN2025-0053 – Sixth Cycle Housing Element Implementation, including the adoption of Objective Design Standards for Multiple-Family and Mixed-Use Residential Developments; finds that: (a) Stanislaus County prepared an Addendum to the certified Environmental Impact Report (EIR) for the County's General Plan (State Clearinghouse No. 2014042087) in compliance with the CEQA (Public Resources Code Section 21000 et seq.) together with the State CEQA Guidelines (California Code of

Regulations, Title 14, Section 15000 et seq.); (b) the project meets the requirements for preparation of an addendum to a certified EIR as laid out in CEQA Guidelines Section 15164 and does not involve any significant new information which would trigger any new or greater impacts to the environment necessitating development of a Subsequent or Supplemental EIR as required by CEQA Guidelines Sections 15162 and 15163; (c) the Addendum has been prepared in compliance with CEQA, the State CEQA Guidelines, and the County's CEQA Guidelines and Procedures for the Implementation of CEQA; (d) accepted the Addendum to the certified EIR prepared for the County's General Plan and finds that the Addendum reflects Stanislaus County's independent judgement and analysis; and, (e) ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder's Office pursuant to Public Resources Code Section 21166; finds and declared: (a) the County of Stanislaus is required by California Government Code Sections 65580–65589.8 to adopt a Housing Element as part of its General Plan that adequately accommodates its share of the Regional Housing Needs Allocation (RHNA) across all income levels; (b) the County's 2023-2031 Housing Element identifies a shortfall in available sites zoned for residential development at appropriate densities to meet the RHNA; (c) to address this shortfall and comply with the requirements of California Government Code Sections 65583.2(h) and 65583.2(i), the County must rezone sites to allow residential development at minimum densities of 20 dwelling units per acre and permit multi-family housing by-right, with ministerial approval processes for qualifying projects that include at least 20 percent of units affordable to lower-income households; (d) the County has identified 48 parcels in the unincorporated area that are suitable for rezoning based on criteria including proximity to infrastructure, transit access, and existing land use compatibility, and an additional 91 parcels to be rezoned to provide additional residential capacity but were not included in the Housing Element Sites Inventory; (e) the proposed rezoning implements the sixth cycle Housing Element Action 3-1g, is consistent with the goals, policies, and implementation programs of the County's General Plan and Housing Element, and supports the development of safe, decent, and affordable housing for current and future residents; (f) the parcels proposed to be rezoned to accommodate the shortfall identified in the County's sixth cycle Housing Element, as listed in Exhibit F – Summary of Rezone Sites by Neighborhood/Community of Attachment 1, are subject to the following standards (detailed in Housing Element Action 3-1g): (i) permit owner-occupied and rental multi-family uses by-right for developments in which 20 percent or more of the units are affordable to lower-income households. "By-right" means approval without discretionary review; (ii) permit the development of at least 16 units per site; (iii) establish a minimum density of 20 units per acre and a maximum density of at least 20 units per acre for all rezone sites to accommodate lower-income RHNA; and (iv) ensure that either: a) at least 50 percent of the shortfall of low- and very low-income regional housing need can be accommodated on sites designated for exclusively residential uses; or b) if accommodating more than 50 percent of the low- and very low-income regional housing need on sites designated for mixed uses, all sites designated for mixed uses must allow 100 percent residential use and require that residential uses occupy at least 50 percent of the floor area in a mixed-use project; finds, based on the discussion in the October 16, 2025, Planning Commission Memo, Attachment 1, of the agenda item, and the whole of the record that: (a) the General Plan Amendment will maintain a logical land use pattern without detriment to existing and planned land uses; (b) the County and other affected governmental agencies will be able to maintain levels of service consistent with the ability of the governmental agencies to provide a reasonable level of service; (c) the amendment is consistent with the General Plan goals and policies; approved General Plan Amendment, Rezone, and Ordinance Amendment Application No. PLN2025-0053 – Sixth Cycle Housing Element Implementation, including approval of the Stanislaus County Objective Design Standards; and, introduced, waived the reading, and adopted ordinances for the approved Rezone and Ordinance Amendment Application No. PLN2025-0053 – Sixth Cycle Housing Element Implementation – Planning
