Invocation was given by Deacon Greg Masztal with Saint Paul’s Episcopal Church.

Kassandra Barrientos, with the Stanislaus Council of Governments (StanCOG), gave a presentation on StanCOG’s Unmet Transit Needs Analysis.

Deahna Washington voiced concerns regarding a neighbor burning refuse near her property and the difficulties she is having obtaining enforcement from multiple agencies. She asked the Board for assistance in clarifying the rules and ensuring accountability within her neighborhood.

Milt Trieweiler, a lifetime Stanislaus County resident, urged the Board to remain open-minded and objective when making hard decisions and shared they have an obligation to plan for the welfare of future children and descendants.

Kelley Coelho, a member of the Veterans Advisory Commission, shared a proposal for veterans housing intended to serve the long-term needs of veterans in Stanislaus County.

Kevin McClarty, a constituent of District 3, shared concerns regarding the proposed overnight camping at Tuolumne River Regional Park. He also voiced concerns regarding the design of the new courthouse.

Condit absent) **7.2** Conducted a public hearing to consider the Planning Commission’s recommendation of approval for Rezone and Parcel Map Application No. PLN2023-0099 – Power Play, a request to rezone a 9.33± acre parcel from Planned Development (P-D) (25) to a new P-D, to include an indoor roller hockey facility, 60,834 square feet in size, as a permitted use and to divide the project site into eight parcels, located at 711 Bangs Avenue and 4555 North Star Way, between Galaxy Way and Bangs Avenue, in the Modesto area, and adoption of a Negative Declaration; adopted the Negative Declaration pursuant to CEQA Guidelines Section 15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Negative Declaration reflects Stanislaus County’s independent judgment and analysis; ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder pursuant to Public Resources Code Section 21152 and CEQA Guidelines Section 15075; finds that: (a) the project is consistent with the overall goals and policies of the County General Plan; (b) the proposed Planned Development zoning is consistent with the Planned Development General Plan designation; (c) the proposed parcel map is consistent with applicable general and specific plans as specified in Section 65451 of California Code, Government Code; (d) the design or improvement of the proposed parcel map is consistent with applicable general and specific plans; (e) the site is physically suitable for the type of development; (f) the site is physically suitable for the proposed density of development; (g) the designs of the parcel map or the proposed improvements are not likely to cause substantial environmental damage or substantially and avoidably injure fish and wildlife or their habitat; (h) the design of the parcel map or type of improvements is not likely to cause serious public health problems; (i) the design of the parcel map or the type of improvements will not conflict with easements, acquired by the public at large, for access through or use of, property within the proposed subdivision; (j) the project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements; approved Rezone and Parcel Map Application No. PLN2023-0099 – Power Play, subject to the Development Standards and Development Schedule, attached to the agenda item; and, introduced, waived the reading, and adopted Ordinance C.S. 1406 – Planning ORD-59-C-1 2025-0695
