IV. Annual EDA Regional Update Visit – Overview of the Economic Development Administration (EDA) and Funding Opportunities Based on Stanislaus County's Comprehensive Economic Development Strategy (CEDS) Document – Wil Marshall, EDA Regional Representative

Keith introduced Wil Marshall and Julie Fonseca from the Regional Economic Development Administration (EDA) who had been invited to provide an annual EDA update and discuss funding opportunities.

As the EDA Regional Representative, Wil Marshall is one of two persons that cover the western region which includes 21 counties in California and three in Nevada. He encouraged this Committee to strive for 50% of their membership to include the private sector. The purpose of the EDA is to assist cities/communities to strengthen local economies and their financing infrastructure that will attract private sector firms and bring jobs to the area (100+). Wil is available to answer questions member cities may have on the application process or funding of projects.

Mr. Marshall provided an overview of the four programs offered through EDA (non-profits, Indian reservations):

- <u>Public Works Program</u> Empowers distressed communities to revitalize, expand, and upgrade their physical infrastructure to attract new industry, encourage business expansion, diversify local economies, and generate or retain long-term, private sector jobs and investment. - <u>Technical Assistance</u> Helps fill the knowledge and information gaps that may prevent leaders in the public and nonprofit sectors in distressed areas from making optimal decisions on local economic development issues. The Local Technical Assistance program helps analyze the feasibility of potential economic development projects, such as an industrial park or a high-technology business incubator. - Economic Adjustment Assistance Assists state and local interests in designing and implementing strategies to adjust or bring about change to an economy. The program focuses on areas that have experienced or are under threat of serious structural damage to the underlying economic base. Under Economic Adjustment, EDA administers its Revolving Loan Fund (RLF) Program, which supplies small businesses and entrepreneurs with the gap financing needed to start or expand their business.
