Based on that determination, a fee reduction from the original amount of \$25,208 to 20% of the original amount, \$5,041.60, was proposed to the requestor. The requestor accepted the

proposed reduction, and member Ferreira motioned to approve the 80% fee reduction and authorize the PFF Committee Chair to issue a letter to the requestor stating the revised fee amount to be paid to the City of Turlock, which was seconded by alternate member Valencia.

Re: Request for Public Facilities Fee Deferral / Waiver – Geer Family Apartments, 4131 Geer Rd., Turlock (the "Geer Project")

Dear Chairman Cavanah,

On behalf of Milestone Housing Group LLC., my joint venture partner for the Geer Project, I am submitting this formal request to the PFF Committee for deferral and waiver of applicable Public Facility Fees related to the proposed workforce housing project we are developing at 4131 Geer Rd in Turlock.

Geer Family Apartments is a fully entitled, all affordable, family apartment community. The project will bring 259 new apartment units with income limits covering a broad range of the population in Turlock (units from 30% to 80% of the Stanislaus County area median income). Given the high costs of construction in California, current interest rates and the competitive funding environment for affordable housing, City and County financial participation, through fee waivers, deferrals and other means, is a critical component to getting projects built and into the County's affordable housing inventory.

Project Summary

Geer Family Apartments is located in northeast Turlock at the intersection of Geer Road and Christopherson Parkway, across the street from California State University, Stanislaus. The property is in a Difficult to Develop Area (DDA) and a HCD Highest Resource areas. These designations reflect desirable locations for workforce housing development as they prioritize area demographics with positive economic, educational, and health outcomes for low-income families, particularly long-term outcomes for children.

The property is located close to many amenities that will benefit the residents. Medeiros Elementary School, Dennis Earl Elementary School and Christopherson Park are within a few blocks on either side of the property. There is a Turlock Transit city bus stop along the property line that provides bus service at roughly every half hour during commuting times. Raley's, CVS, Walmart Neighborhood Market and several other stores and restaurants are within walking distance as well.

Geer Family Apartments was approved by the City of Turlock in January of 2023 for a total of 261 total units (including 2 manager's units), a club house and common area amenities. Of the 259 family affordable units, approximately 50% of the units will be one bedroom, 25% two bedrooms and 25% three bedrooms. The design is comprised of multiple 3-story walk up apartment buildings and a standalone community building which will include a shared kitchen, computer room, additional community spaces and leasing offices. There are also outdoor amenities, including gathering spaces,

community garden, recreation areas and a tot lot. 4131 Geer Road is currently 8.58 acres of undeveloped land.

The unit mix is as follows:

126 one bedrooms of approx. 564 SF (net rentable)

66 two bedrooms ranging from approx. 821 to 810 SF (net rentable)

69 three bedrooms of approx. 1065 SF (net rentable)

The site plan includes 458 total parking spaces, a portion of which may have carports to accommodate solar panels used to satisfy building code energy generation requirements.

Geer Family Apartments will have 259 apartment units that are income and rent restricted to households earning between 30% and 80% of the Stanislaus County Area Median Income, with an overall average of 60% or less.

Affordability restrictions may ultimately vary depending on final funding sources, however they are currently anticipated as follows:

30 units at 30% AMI (extremely low income)

24 units at 50% AMI (very low income)

151 units at 60% AMI (low income)

54 units at 80% AMI (low income)

2 manager's units (market rate)

Milestone will pursue a combination of City, County and State funding through various affordable housing programs.

Stanislaus County Public Facility Fees

Geer Family Apartments will be developed with the assistance of public funds, conventional debt and equity and will be subject to a deed restriction to ensure affordability for 55 years.

The Stanislaus County Public Facility Fees 2021 Administrative Guidelines provide provisions under Section III, E. 1) for housing developed for occupancy by moderate and low income households (50% to 120% of the area median income) to defer Public Facilities Fees for the entire time period that the income eligibility, as set by the funding source, is maintained.

The Administrative Guidelines further state housing developed for occupancy by extremely and very low-income households (50% and less of area median income) shall be afforded the opportunity to waive the entire Public Facilities Fees.

Milestone hereby requests a deferral on Public Facilities Fees of approximately 229 very-low to low-income units and a waiver of Public Facilities Fees for approximately 30 extremely low income units. Milestone shall provide documentation that confirms such occupancy prior to building permit issuance.

Milestone acknowledges a contract will be executed and recorded that indicates a) the deferral for very low and low income units with instructions regarding future payment and b) the waiver status for extremely low income units along with instructions regarding future payment should the income housing status not be maintained. Furthermore, Milestone understands the administrative fee portion of such Public Facilities Fees shall not be deferred and shall be paid at time of building permit issuance.

To Whom it May Concern,

Please take notice of this request for appeal of the fees associated with building permit 2022-00001573 that was paid on 8/29/23 in the amount of \$73,170.94.

On September 29, 2023, a formal appeal was filed with the City of Turlock due to the impact and development fees and road fees included in the permit. On December 4, 2023, Valley Milk met with the City of Turlock officials to review the appeal and was informed that an additional appeal was required to dispute the county fees included in the building permit.

As a result of this project for which the permit was filed, Valley Milk will be reducing the outbound freight traffic by 2 trucks/day or 50% of the outbound freight for cream trucks. Additionally, Valley Milk will be reducing the amount of inbound milk tankers to the plant by 2 trucks/day. This is a reduction in the traffic on the road, making the city of Turlock more sustainable, reduces carbon emissions and reduces the potential for traffic accidents. From a growth standpoint, this new addition will bring in additional employees who will work one shift per day and require two operators per shift. This will add two passenger vehicles to the road daily. There is no justification for Valley Milk to pay \$21,471 in roads, transportation, and infrastructure fees when we are reducing the impact on the roads, city, and county. We respectfully request that the RTIF be eliminated from the permit fees.

I look forward to your prompt response regarding this issue.
