NOTICE OF EXEMPTION

Project Title: Duarte Nursery Hughson Public Water System (5000465)

Description of Project: The project involves permitting a replacement water well for the Duarte Nursery, Inc. Public Water System serving the on-site potable water demands for a commercial agricultural nursery in Hughson, CA. To the best of the record that can be reasonably determined the existing well was drilled decades ago and has outlasted its useful service life, but more significantly the water derived from the well no longer can meet drinking water standards for Nitrate, Arsenic, and 1,2,3,-TCP. Test wells drilled on the property show that the water quality in the deeper strata of the same water aquifer system (480 to 500 feet below ground surface) can meet the drinking water requirements for these constituents. The existing well will be replaced by two proposed wells (GH15W and GH15E) of identical design and capacity to provide 100% system redundancy in the event of interrupted service and/or rotating maintenance schedules. The two "replacement" wells will be plumbed into the existing distribution system and will not be used to create any new potable or non-potable demand. The existing well serving the property will be destroyed as soon as possible after the new wells are functioning and online. The new "replacement wells" are found to be exempt from any further CEQA review as they constitute a categorical exemption (like-for-like) replacement of an existing facility.
