Building Homes and Jobs Act

Building Homes and Jobs Act GC 27388.1, effective Jan. 1, 2018, requires a \$75 tax be paid at the time of recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, except those expressly exempted from payment of recording fees, per each single transaction per parcel of real property. The fee imposed by this section is not to exceed \$225.

Exemptions:

- Exempt from fee per GC 27388.1 (a)(2); recorded concurrently "in connection with" a transfer subject to the imposition of documentary transfer tax (DTT).
- Exempt from fee per GC 27388.1 (a)(2); recorded concurrently "in connection with" a transfer of real property that is a residential dwelling to an owner-occupier.
- Exempt from fee per GC 27388.1 (a)(1); fee cap of \$225.00 reached.
- Exempt from the fee per GC 27388.1 (a)(1); not related to real property.

Failure to include an exemption reason will result in the imposition of the \$75 Building Homes and Jobs Act fee. Fees collected are deposited to the State and may not be available for refund.

Real Estate Fraud Prosecution Fee

A \$3.00 fee is charged on the majority of recorded documents.

Except:

- No Fee documents.
- Document subject to Documentary Transfer Tax per California State Revenue and Taxation Code 11911 such as a Grant Deed.
- Documents recorded in connection with a Grant Deed subject to Documentary Transfer Tax.
