Stantec – SB 552 County Drought Resilience Plan Short-term Response Actions and Long-term Mitigation Strategies and Actions.

Mayor Sue Zwahlen asked if the plan was for providing response services for all emergency outage events and Supervisor Withrow indicated that the County is 10 years ahead and a leader in the state, as it is enabled to provide necessary short and long-term mitigation efforts in response to drought and other emergency events. Christy McKinnon agreed and said that development of the County Drought Plan will be an opportunity to put all the vital information in one place so that it is accessible to the public and available for all partner agencies. Ruben Wagner clarified that the Office of Emergency Services has not had to put mutual aid agreements into effect in the past in response to severe and prolonged drought events because the emergency response services provided by Self-Help Enterprises has been adequate to address the County's needs. Additional Drought Task Force Meetings have been set for January 28, and

Modesto Subbasin STRGBA Groundwater Sustainability Agency Workshop #3

Delta Mendota Subbasin Newsletter –

Christy McKinnon provided a summary of the information included in the Delta-Mendota Groundwater Subbasin's June 2025 Newsletter. Subbasin representatives continue to work with state board staff to address concerns regarding water quality. The 23 GSAs are hopeful that the state will complete review of the single GSP in early 2026 and find that the Plan is in compliance with GSP regulations so that the Subbasin avoid probationary status and be returned to the Department or Water Resources for oversight. The Jarrett Martin, with the San Joaquin River Exchange Contractors has taken over as Subbasin Plan manager due to the retirement of John Brodie. The Subbasin is making progress on implementation of projects made possible by the 7.6 million SGMA round 1 award. These projects include model updates, water quality studies, recharge projects, monitoring and closing data gaps, and public outreach.
