<b>WASTE ACCEPTED:</b>	Residential and commercial waste. If you have <b>televisions, computers, or other electronic waste you must notify the attendant so appropriate paperwork can be filled out. Batteries have their own designated site, so please let attendant know (AAA, AA, C, D Cell, etc.). Appliances, mattresses and tires have a separate pricing structure and must be declared so that they can be separated for diversion.</b>

<b>WASTES NOT ACCEPTED:</b>	Hazardous waste, household hazardous waste ( <b>HHW</b> ), radioactive waste, toxic materials, fluorescent light bulbs, no free-flowing liquids, paint thinners, used oil, car bodies, septic tank waste, closed containers, car batteries. This list is not all inclusive and County staff reserves the right to not accept any type of waste regardless of its designation. <b>For proper disposal of Hazardous Waste &amp; HHW, contact the County's Household Hazardous Waste Facility @ (209) 525-6789. This facility is located at 1710 Morgan Road, Modesto, CA.</b>

### PRICE BY THE LOAD

1.	Passenger cars, SUV's, Pickups ( <b>without sideboards</b> ) and Vans	<b>\$12.00</b>
2.	Two-wheel trailers <b>without sideboards &amp; within the following dimensions:</b> 8' maximum length, 3' maximum height	<b>\$12.00</b>
3.	Four-wheel trailers <b>without sideboards &amp; within the following dimensions:</b> 8' maximum length, 3' maximum height	<b>\$18.00</b>
4.	Pickup <b>w/o sideboards</b> + Two-wheel trailer <b>w/o sideboards*</b>	<b>\$24.00</b>
5.	Pickup <b>w/o sideboards</b> + Four-wheel trailer <b>w/o sideboards*</b>	<b>\$30.00</b>

**Note: Sideboards mean anything used to contain the load and extend the height of a pick-up bed or trailer. Trailers are measured in entirety from the outside, end-to-end (excluding tongue), and bottom-to-top. \*If both contain any amount and any type of refuse.**

### PRICE BY THE TON

**WEIGHED VEHICLES ARE ALL PICKUPS AND TRAILERS WITH SIDEBOARDS, TRAILERS OVER THE MAXIMUM LENGTH AND/OR HEIGHT, ALL FLATBED PICKUPS, MODIFIED PICK-UPS WITH TOOLBOXES AND DUAL WHEELS, AND ALL OTHER VEHICLES NOT LISTED IN OTHER CATEGORIES.**

<b>Normal Refuse:</b> Garbage, paper, lumber, bottles, cans, small dead (household) animals, household trash, garden refuse, demolition, construction debris, dirt, rock, gravel, concrete, asphalt, plaster, brick, roofing tile and sheetrock. <b>For loads of dirt, a lab analysis may be required.</b>	<b>\$40.00/ton</b>

<b>Special Handling:</b> Any material that requires a special hole dug and must be buried immediately as determined by Landfill administration (e.g., Treated wood waste, non-friable asbestos*, dead animals**). <b>Must be pre-approved by Landfill staff</b>  <b>ACCEPTED ONLY Tuesday-Friday, 9 a.m. to 2 p.m. Customers must call ahead to schedule an appointment for disposal of these materials.</b>  * Taken only with approval letter from the Stanislaus County Department of Environmental Resources Hazardous Materials Division. Please contact them at (209) 525-6700 to obtain the approval letter.  ** Large loads of dead animals require a written request from the Stanislaus County Director of Emergency Services.  *** Price is per dead animal or \$120.00/ton, whichever is greater. (Large dead animals include horses, cattle, llamas, mules, donkeys. Other dead animals include goats, feeder pigs, sheep, calves, breeding sows, and boars.)	<b>\$120.00/ton</b> or <b>\$120.00***</b> each for large dead animals or <b>\$36.00</b> each for 5 or fewer other dead animals or <b>\$24.00</b> minimum fee for Non-Friable Asbestos

<b>Hard-to-Handle (Bulk Material):</b> RV trailers, mobile homes, large plastic sheets, wire, bailing twine, tree stumps/logs & whole trees, large tanks, long/large pipe (over 4 feet), large chunks of concrete over 2'x2'x2', boats, pontoons, large sheets of foam or aluminum siding, sensitive records, spoiled/damaged finished food products, large loads of irrigation line & all other material over 4'x4'x4'.  <b>ACCEPTED ONLY Tuesday-Friday, 9 a.m. to 2 p.m. Can only accept 1 mobile home/day. # SITE RULES

## ALL CUSTOMERS USING THE FINK ROAD LANDFILL MUST OBEY THE FOLLOWING RULES:

1. **SAFETY FIRST.** Signs are posted, and rules are strictly enforced.
2. For your safety and ours, please keep all children and pets in your vehicle. This facility is considered a construction area. As such, large trucks and equipment will be moving all over the landfill.
3. Do not travel outside the area in which you have been designated to unload your vehicle. Please remember that you are at a landfill and always be aware of your surroundings.
4. While unloading, refrain from throwing objects from your vehicle. It is unsafe for you and for those around you.
5. Do not back up your vehicle and slam on the breaks to dislodge your load. Doing so is very unsafe to you and those around you. (If special handling is required, please call ahead of time before coming to the site).
6. Unacceptable and/or hazardous wastes cannot be accepted at the landfill. Most of the communities in Stanislaus County have a designated area for these types of waste. We would be pleased to give you information on where to dispose of these items. Feel free to ask the scale house attendant or the traffic director/spotter at the tipping area.
7. Salvaging is strictly prohibited.
8. **UNAUTHORIZED AREAS ARE STRICTLY OFF LIMITS.**
9. All California State vehicle codes are strictly enforced within the landfill.
10. ALL loads arriving at the landfill must be tarped and tied down before driving on any public roads, and must remain so, including while on the scale, until arrival at the untarping area within our facility. **The first time you enter the landfill with an uncovered, uncontained load, you have the option of either paying a double disposal fee or buying a tarp. Future reoccurrences will be subject to a double disposal fee, and you will not have the option to purchase a tarp. Commercial customers, due to the magnitude in size of commercial vehicles/containers, will be charged a flat fee of \$100 for an uncovered load.** The covering and proper containment of waste while being transported in vehicles on roadways is not only the law (i.e., CA Vehicle Code Section 23115) but it helps keep county and landfill roadsides clear of debris and litter free.
