Project Description: Applicant(s) has applied for a Stanislaus County Food Processing By-product Use permit for land application of food processing by-products. This project includes the land-application of food processing by-product mud, consisting of tomato and bean plant material and soil rinsed from the produce, dredged from the ConAgra facility large aerated pond and by-product rinse mud generated from the rinsing of produce prior to processing to be utilized as soil amendments on active farmland and orchards. These activities would be performed and enforced under the Stanislaus County Ordinance, Chapter 9.88, for food processing by-product use. Subject land application parcels total approximately 1,056.7 acres. With required by-product application setbacks, subject land application parcels total approximately 802 usable acres for by-product application. Land application will typically occur during spring, summer and fall months. Application of by-product materials would not exceed limits based on agronomic rates for the crops and trees that are planted.
